RELEASE OF SECURITY INTEREST IN TRADEMARKS

This RELEASE OF SECURITY INTEREST IN TRADEMARKS (this “Release”) is effective as of October 6, 2022, and is given by COÖPERATIEVE RABOBANK U.A., NEW YORK BRANCH, in its capacity as agent for the lenders (in such capacity, the “Administrative Agent”), with its principal offices at 245 Park Avenue, New York, New York 10167, in favor of SUMMIT HILL FOODS, INC. (formerly known as SOUTHEASTERN MILLS, INC.) a Georgia corporation and JMH INTERNATIONAL, LLC, a Georgia limited liability company (collectively, jointly and severally “Grantors” and each individually “Grantor”). Capitalized terms not defined herein shall have the meanings given to them, directly or by reference, in the Trademark Security Agreement (as defined below).

WHEREAS, each Grantor and certain other Grantors have executed and delivered that certain Trademark Security Agreement in favor of the Administrative Agent and dated as of November 14, 2019 (as modified by that certain Trademark Security Agreement supplement dated as of April 24, 2020, and as further modified by that certain Partial Release of Security Interest in Trademarks dated as of August 2, 2022, the “Trademark Security Agreement”), which was recorded in the Assignment Division of the United States Patent & Trademark Office on November 18, 2019 at Reel 6796, Frame 0419, and which supplement was recorded on April 24, 2020 at Reel 6923, Frame 0325;

WHEREAS, pursuant to the Trademark Security Agreement, each Grantor granted to the Administrative Agent a continuing security interest (the “Security Interest”) in its trademarks listed on Schedule 1 hereto (such trademarks of Grantors being the “Trademark Collateral”); and

WHEREAS, Administrative Agent now desires to release its Security Interest in the Trademark Collateral.


NOW, THEREFORE, for good and valuable consideration, receipt of which is hereby acknowledged, Administrative Agent hereby (i) terminates, releases, and discharges the Security Interest in the Trademark Collateral, and (ii) re-assigns to the applicable Grantor any right, title or interest it may have in the Trademark Collateral, in each case without recourse to the Administrative Agent and without representation or warranty of any kind. The Administrative Agent further agrees to execute and deliver to the Grantors any and all further documents and instruments, and do any and all further acts which the Grantors (or their agents or designees) reasonably request (at the Grantor’s sole cost and expense) in order to confirm this release and the Grantor’s right, title and interest in, to and under the Trademark Collateral listed on Schedule 1 hereto. The Administrative Agent hereby authorizes the Grantors, or any successor to the Grantors (including any person or entity hereafter holding any right, title or interest in or to the Trademark Collateral) to record this Release with the United States Patent and Trademark Office.


