**TERMINATION AND RELEASE OF
TRADEMARK SECURITY AGREEMENT**

THIS TERMINATION AND RELEASE OF TRADEMARK SECURITY AGREEMENT (this "Release") is made as of this 5th day of October 2022, by CITIBANK, N.A., in its capacity as agent ("Agent"), in favor of TEAM INTERNATIONAL GROUP OF AMERICA, INC., a Florida corporation ("Grantor").

WHEREAS, Grantor entered into a certain Trademark Security Agreement, dated August 6, 2021, with Agent, notice of which was recorded with the United States Patent and Trademark Office ("USPTO") on August 12, 2021, at reel/frame 7389/0918, (the "Trademark Security Agreement"). Capitalized terms used but not otherwise defined herein have the meanings given to them in the Trademark Security Agreement.

FOR GOOD AND VALUABLE CONSIDERATION, the receipt and adequacy of which are hereby acknowledged, Agent hereby (a) releases, terminates and discharges its security interest in the Trademarks, including the Trademarks listed on Schedule I attached hereto and made a part hereof, (b) terminates the Trademark Security Agreement and (c) assigns, transfers and conveys to Grantor any right, title or interest, including the security interest, it may have in the Trademarks. Grantor, or any successor to Grantor (including any person or entity hereafter

having any right, title or interest in or to the Trademarks), is hereby authorized to record this Release with the USPTO.
