CONFIRMATORY TRADEMARK ASSIGNMENT

This Assignment Agreement (the "Agreement") is made by and between **BAUSCH HEALTH COMPANIES INC.**, with its registered office at 2150 ST. ELZEAR BLVD., WEST LAVAL, QUEBEC CANADA H7L 4A8 ("Assignor"), and **BAUSCH + LOMB IRELAND LIMITED**, a company registered in Ireland having its registered office at 3013 Lake Drive, Citywest Business Campus, Dublin 24 ("Assignee"); each a "Party" and together the "Parties",

WHEREAS, Pursuant to a Business Transfer Agreement, the registrations set forth on Schedule A (collectively, the "Trademarks") were transferred to the Assignee; and

WHEREAS, The Parties wish to enter into this Assignment to confirm that the Assignee is the legal owner of the Trademarks.

NOW, THEREFORE, in consideration of the mutual promises set forth in this Agreement and for other good and valuable consideration, the receipt of which is hereby acknowledged, the parties hereby agree as follows:

1. Assignment of Trademarks. Assignor does hereby confirm that it has sold, conveyed, assigned, and transferred to Assignee all of Assignor's right, title and interest in and to (i) the Trademarks, together with the goodwill symbolized thereby, and (ii) all benefits, privileges, causes of action, common law rights, and remedies relating thereto throughout the world, including, without limitation, all of Assignor's rights to (a) apply for and maintain all registrations, renewals and/or extensions thereof, (b) bring actions and recover damages for past, present and future infringement or other violation thereof, and (c) grant licenses or other interests therein.

2. Successors and Assigns. This Agreement and all of its provisions shall be binding upon and inure to the benefit of the parties hereto and their respective permitted successors and assigns.

3. Governing Law; Jurisdiction. This Agreement shall be governed in all respects by the laws of Ireland, without giving effect to the principles of conflicts of law thereof.

4. Counterparts. This Agreement may be executed in one or more counterparts, each of which shall be deemed an original, but both of which together shall constitute one and the same instrument.
