**TERMINATION AND RELEASE OF
FIRST LIEN SECURITY INTEREST IN TRADEMARKS**

This Termination and Release of First Lien Security Interest in Trademarks (“Release”) is made as of October 6, 2022, by **UBS AG, STAMFORD BRANCH** (“Collateral Agent”) in favor of **COMMUNICATIONS AND POWER INDUSTRIES LLC**, a Delaware limited liability company with an address at 811 Hansen Way, Palo Alto, California 94304, **CPI MALIBU DIVISION**, a California corporation with an address at 811 Hansen Way, Palo Alto, California 94304, and **CPI LOCUS MICROWAVE, INC.**, a Delaware corporation with an address at 811 Hansen Way, Palo Alto, California 94304 (each, a “Grantor” and collectively, the “Grantors”).

W I T N E S S E T H:

WHEREAS, the Grantors entered into a certain trademark security agreement dated July 26, 2017 (the “Trademark Security Agreement”) with Collateral Agent, notice of which was recorded on July 26, 2017 at the United States Patent and Trademark Office at Reel 6115, Frame 0155.

Capitalized terms used but not otherwise defined herein have the meanings given to them in the Trademark Security Agreement.

WHEREAS, each Grantor granted the Collateral Agent, under the terms of the Trademark Security Agreement, a continuing security interest (the “Security Interest”) in favor of the Collateral Agent, in all of each such Grantor’s right, title and interest in, to and under the Trademark Collateral, including the trademarks and trademark applications listed in **Schedule A** (collectively, the “Released Trademark Collateral”).


WHEREAS, the Collateral Agent has agreed to terminate and release its security interest in all such Released Trademark Collateral as herein provided.

NOW, THEREFORE, in consideration of the foregoing and intending to be legally bound, the Collateral Agent hereby releases, terminates and discharges any and all of its interest in the Released Trademark Collateral of the Grantors, and assigns, transfers and conveys to Grantors any interest in such intellectual property, including the Security Interest. If and to the extent that the Collateral Agent has acquired any right, title or interest in and to the Released Trademark Collateral under the Trademark Security Agreement, the Collateral Agent, without representation or warranty of any kind, hereby re-transfers, re-conveys and re-assigns such right, title or interest to the Grantors.
