## INTELLECTUAL PROPERTY ASSIGNMENT AGREEMENT

This Intellectual Property Assignment Agreement (“Agreement”) is made by and between SSI G. This Agreement shall serve as an automatic assignment to Assignee of all intellectual property identified in Appendix A.

Assignors, their successors, assigns, and other legal representatives agree to execute any and all papers, including applications for trademark or service mark registrations of any and all kind and in any and all countries and to perform any and all acts which Assignee, its successors, assigns, or other legal representatives may deem necessary and reasonably requested to secure thereto the rights assigned herein.

The Parties hereby agree that a copy of this Agreement may be filed with the United States Patent and Trademark Office and any other equivalent foreign intellectual property office.




