**RELEASE OF SECURITY INTEREST
IN INTELLECTUAL PROPERTY COLLATERAL**

THIS RELEASE OF SECURITY INTEREST IN INTELLECTUAL PROPERTY COLLATERAL (this “**Release**”), dated as of October 11, 2022, is made by Ares Capital Corporation, as collateral agent (the “**Collateral Agent**”) in favor of Mac Lean-Fogg Company, a Delaware corporation, MacLean Power, L.L.C., a Delaware limited liability company, MacLean Royal Oak, L.L.C., a Delaware limited liability company, MacLean Saegertown, L.L.C., a Delaware limited liability company, and MacLean Senior Industries, L.L.C., a Delaware limited liability company (collectively, the “**Grantors**”), as follows:

WITNESSETH:

WHEREAS, pursuant to that certain Pledge and Security Agreement dated as of December 21, 2018 (as amended, supplemented or otherwise modified from time to time, the “**Pledge and Security Agreement**”), among the Grantors and the other parties party thereto in favor of the Collateral Agent, and those certain agreements described on **Annex I** attached hereto (each, an “**IP Security Agreement**” and collectively, the “**IP Security Agreements**”), the Grantors granted a security interest in certain collateral in favor of the Collateral Agent, including the IP Collateral (as hereinafter defined); and

WHEREAS, the Collateral Agent now desires to terminate and release the IP Security Agreements and the entirety of its security interest in the IP Collateral.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, and upon the terms set forth in this Release, the Collateral Agent hereby agrees as follows:

1. Definitions. The term “**IP Collateral**”, as used herein, shall mean all of each Grantor’s right, title or interest in, or to any and all of the Intellectual Property Collateral, including the Trademarks, Patents and Copyrights listed on **Annex II** attached hereto. Capitalized terms not defined herein have the meanings set forth in the Security Agreement or the applicable IP Security Agreement, as applicable.

2. Release of Security Interest. The Collateral Agent, without recourse, representation or warranty and at the Grantors’ sole cost and expense, hereby terminates and cancels the IP Security Agreements and terminates, cancels, releases, relinquishes and discharges, in its entirety, for the benefit of the Grantors, and their successors and assigns, its security interest in and to the IP Collateral and any and all right, title and interest of the Collateral Agent in, to and under the IP Collateral shall hereby be terminated, cancelled, released, relinquished and discharged. The Collateral Agent hereby authorizes the Grantors and their successors, assigns or other legal representatives to file this Release with the United States Patent and Trademark Office and the United States Copyright Office, at the sole expense of the Grantors, to evidence and effectuate the release and termination of the Collateral Agent’s security interest in the IP Collateral.

3. Delivery by Facsimile. Delivery of an executed signature page to this Release by facsimile or electronic (including .pdf file) transmission shall be as effective as delivery of a manually signed counterpart of this Release. The parties hereby agree that the electronic signatures of the parties will have the same force and effect as a manual signatures.

4. Governing Law. THIS RELEASE AND THE RIGHTS AND OBLIGATIONS OF THE PARTIES HERETO SHALL BE GOVERNED BY, AND CONSTRUED AND INTERPRETED IN ACCORDANCE WITH, THE LAW OF THE STATE OF NEW YORK.
