**TERMINATION AND RELEASE OF
TRADEMARK SECURITY AGREEMENT**

THIS TERMINATION AND RELEASE OF TRADEMARK SECURITY AGREEMENT (this "Termination"), is dated as of September 24, 2020, and made by **PNC BANK, NATIONAL ASSOCIATION**, in its capacity as Agent under the below-defined Security Agreement ("Grantee") to **UNICARE PHARMACY, INC.**, a California corporation and **VITALAB PHARMACY, INC.**, a California corporation (collectively, "Grantors").

WHEREAS, pursuant to that certain (i) Revolving Credit and Security Agreement and Guaranty dated as of March 26, 2019 (as amended, restated, amended and restated, extended, supplemented and/or otherwise modified from time to time, the "Credit Agreement") among Grantors, certain of Grantors' affiliates, the lenders from time to time party thereto and Grantee and (ii) Trademark Security Agreement dated as of March 26, 2019 made by Grantors in favor of Grantee (as amended, restated, amended and restated, extended, supplemented and/or otherwise modified from time to time, the "Security Agreement"), a security interest was granted by the Grantors to Grantee in certain collateral, including the Trademark Collateral (as hereinafter defined);

WHEREAS, the Security Agreement was recorded in the Trademark Division of the United States Patent and Trademark Office ("USPTO") on March 29, 2019, at Reel and Frame 6601/0249; and

WHEREAS, Grantee now desires to terminate and release the Credit Agreement and Security Agreement;

NOW, THEREFORE, for good and valuable consideration, the receipt and adequacy of which are hereby acknowledged, and upon the terms set forth in this Termination, Grantee hereby states as follows:


1. Definitions. The term "Trademark Collateral", as used herein, shall have the meaning set forth in the Credit Agreement and shall mean and include all of the Grantors' right, title and interest of every kind and nature as of the date hereof in the trademarks listed on Schedule A hereto.

2. Release of Security Interest. Grantee hereby terminates the Credit Agreement and terminates, releases and discharges its security interest in the Trademark Collateral and reassigns to the person or persons legally entitled thereto all right, title and interest of Grantee in the Trademark Collateral.
