## TERMINATION AND RELEASE OF TRADEMARK SECURITY AGREEMENT

THIS TERMINATION AND RELEASE OF TRADEMARK SECURITY AGREEMENT (this “*Release*”) is made as of September 28, 2022 and executed by MUFG Union Bank, N.A., as administrative agent for the Lenders (in such capacity, the “*Administrative Agent*”), with reference to the following documents: (1) the Credit, Security, Guaranty and Pledge Agreement, dated as of November 14, 2019 (as amended, modified, supplemented or restated from time to time, the “*Credit Agreement*”) among NEON Rated, LLC, a Delaware limited liability company (the “*Borrower*”), as borrower, the Guarantors referred to therein (collectively with the Borrower, the “*Pledgors*”), the Lenders referred to therein, Administrative Agent and MUFG Union Bank, N.A., as issuing bank; and (2) the Trademark Security Agreement dated as of November 14, 2019 (as amended, modified, supplemented or restated from time to time, the “*Trademark Security Agreement*”), executed by the Pledgors in favor of Administrative Agent, which was recorded at the United States Patent and Trademark Office on November 15, 2019 at Reel 006796 Frame 0910. Terms used but not defined herein shall have the meaning set forth in the Trademark Security Agreement.

WHEREAS, pursuant to the Credit Agreement and the Trademark Security Agreement, the Pledgors have granted to Administrative Agent a continuing security interest in, to and under all of the Pledgors’ right, title and interest in and to the Trademark Collateral (as such term is defined in the Trademark Security Agreement).

Administrative Agent hereby (i) terminates the Trademark Security Agreement and releases and terminates any and all liens, security interests, powers of attorney and any other rights of Administrative Agent granted to Administrative Agent with respect to the Trademark Collateral, including rights in and to the trademarks listed on Exhibit A hereto, by any Pledgor pursuant to the Trademark Security Agreement and (ii) to the extent that Administrative Agent has or shall be deemed to have any right, title or interest in any of the Trademark Collateral, grants, re-assigns, transfers, sets over and conveys to the applicable Pledgor, without recourse, representation or warranty, all of Administrative Agent’s right, title and interest in and to the Trademark Collateral.

This Release and any claims, controversy, dispute or cause of action (whether in contract or tort or otherwise) based upon, arising out of or relating to this Release shall in all respects be governed by, and construed in accordance with, the laws of the state of New York and the applicable federal laws of the United States of America, without regard to any conflict of laws principles that would result in the application of the laws of another jurisdiction.
