2. The Certificate of Incorporation of this Corporation was originally filed with the Delaware Secretary of State on July 18, 2012 under the name Pixlee, Inc. The Amended and Restated Certificate of Incorporation was filed with the Secretary of State of the State of Delaware on November 12, 2014. The Second Amended and Restated Certificate of Incorporation was filed with the Secretary of State of the State of Delaware on April 22, 2016. The Third Amended and Restated Certificate of Incorporation was filed with the Secretary of State of the State of Delaware on November 21, 2017. **"ARTICLE I**
