**SUPPLEMENT TO**  
**TRADEMARK SECURITY AGREEMENT**

This SUPPLEMENT TO TRADEMARK SECURITY AGREEMENT (this “Supplement”) is made as of September 13, 2022 by **RECRUITIQ STAFFING, LLC**, a Texas limited liability company (the “Grantor”) in favor of **CHURCHILL AGENCY SERVICES LLC**, as the Administrative Agent and Collateral Agent for the Secured Parties (in such capacity and together with its successors and permitted assigns, the “Administrative Agent”). Capitalized terms used herein and not otherwise defined herein shall have the meanings assigned to such terms in the Security Agreement (defined below).

WHEREAS, the Grantor, among others, entered into that certain Security Agreement, dated as of December 9, 2021 (as amended, restated, amended and restated, supplemented or otherwise modified from time to time, the “Security Agreement”);

WHEREAS, under the terms of the Security Agreement, the Grantor, among others, executed and delivered to the Administrative Agent that certain Trademark Security Agreement, dated as December 9, 2021 (“Trademark Security Agreement”), granting to the Administrative Agent, for the benefit of the Secured Parties, a security interest in, among other property, certain Trademark Collateral of the Grantors (the “Security Interest”), and which was recorded with the Trademark Division of the United States Patent and Trademark Office (the “USPTO”) on December 9, 2021 at Reel 7524, Frame 0830 pursuant to which the Grantor pledged, assigned and granted a security interest in certain Trademarks (as set forth in Schedule A thereto); and

WHEREAS, the Grantor has developed additional Trademarks and desires to hereby confirm the pledge of, and the grant of a security interest in, such additional Trademarks in favor of the Administrative Agent.

NOW, THEREFORE, in consideration of the mutual covenants herein contained and benefits to be derived herefrom, it is hereby agreed as follows:

1. Supplement to Schedule A. Schedule A to the Trademark Security Agreement is hereby supplemented, but not replaced, by Schedule A-1 annexed hereto. For the purposes of clarity, from and after the date hereof, Schedule A shall be deemed to include (i) the Trademarks referenced on Schedule A as such Schedule A exists immediately prior to the date hereof, and (ii) the Trademarks referenced on Schedule A-1 annexed hereto.
2. Miscellaneous:
  - a. Except as provided herein, all terms and conditions of the Trademark Security Agreement remain in full force and effect.
  - b. This Supplement and the Trademark Security Agreement cover the entire understanding of the parties with respect to the matters set forth herein and supersede all prior discussions and negotiations hereon.

- c. This Supplement may be executed in one or more counterparts and by different parties hereto in separate counterparts, each of which when so executed and delivered shall be deemed an original, but all such counterparts together shall constitute but one and the same instrument.
3. GOVERNING LAW: THIS SUPPLEMENT SHALL BE GOVERNED BY, AND CONSTRUED IN ACCORDANCE WITH, THE LAW OF THE STATE OF NEW YORK, WITHOUT GIVING EFFECT TO ANY CHOICE OF LAW PRINCIPLES THAT WOULD APPLY THE LAWS OF ANOTHER JURISDICTION.
