NOTICE OF RELEASE OF SECURITY INTEREST IN TRADEMARKS

Reference is made to that certain Intellectual Property Security Agreement, dated as of August 5, 2020 (the "Security Agreement") by and between **Silicon Valley Bank** ("Lender") and **Glo Big Boss Ltd.** ("Borrower"), executed by the parties pursuant to that certain Loan and Security Agreement dated as of January 3, 2019, by which Lender extended certain loans to Lender (the "Loan Agreement").

WHEREAS, the Security Agreement was recorded with the United States Patent and Trademark Office (the "USPTO") on August 20, 2020, at Reel 007030, Frame 0151, pursuant to which Borrower granted to Lender a security interest in all right, title and interest of Borrower in and to the trademarks and trademark registrations and applications therefor listed on Schedule A hereto (the "Trademarks");

WHEREAS, in accordance with the provisions of the Loan Agreement and the Security Agreement, Lender wishes to terminate the Security Agreement and release the security interest in the Trademarks and provide a document suitable for recording in the USPTO, for purposes of recording the release, relinquishment and discharge of its security interest in the Trademarks;


NOW, THEREFORE, in consideration of and in exchange for good and valuable consideration, Lender hereby terminates, relinquishes, releases and discharges its security interest in all of Borrower's right, title and interest in the Trademarks, including but not limited to (a) all goodwill associated with or symbolized by the Trademarks; (b) all rights in the foregoing provided by international treaties or conventions, (c) all rights corresponding thereto throughout the world; (d) any and all claims for damages and injunctive relief for past, present and future infringement, dilution, misappropriation, violation, misuse or breach with respect to any of the foregoing, with the right, but not the obligation, to sue for and collect, or otherwise recover, such damages; (e) any and all proceeds of, collateral for, income, royalties and other payments now or hereafter due and payable with respect to, and supporting obligations relating to, any and all of the Trademarks of or arising from any of the foregoing; and (f) all other rights of any kind whatsoever of Lender accruing thereunder or pertaining thereto.

Lender authorizes and requests that the Commissioner of the PTO record this Notice of Release.

This Notice of Release shall be governed by, and construed in accordance with, the laws of the State of California.
