HSBC Bank Canada (as "Secured Party")

RE: That certain credit agreement dated as of January 27, 2015 among, *inter alia*, the Borrower, as borrower, each of the Guarantors identified above and therein, as guarantors (collectively with the Borrower and Fulcrum Capital Partners (Collector) V, LP, the "Debtors"), each of the financial institutions from time to time parties thereto, as lenders (collectively, the "Lenders") and HSBC Bank Canada, as Administrative Agent (the "Secured Party"), as amended by the Amending Agreement No. 1 dated as of July 23, 2015, the Waiver and Consent Agreement and Amending Agreement No. 2 dated as of August 31, 2016, the Waiver and Consent Agreement and Amending Agreement No. 3 dated as of July 27, 2017 and the Consent Agreement and Amending Agreement No. 4 dated as of June 1, 2018 (as amended, supplemented, replaced, restated or otherwise modified from time to time collectively, the "Existing Credit Agreement").

WHEREAS, pursuant to the Existing Credit Agreement, the Secured Party recorded certain Notice of Security Interests ("Notices") at the Canadian Intellectual Property Office ("CIPO") and at the United States Patent and Trademark Office ("USPTO") against the Canadian and United States patents, including applications therefor, and trademarks, including applications therefore, set out on Schedule "A" (Patents) and Schedule "B" (Trademarks) hereto.

FOR GOOD AND VALUABLE CONSIDERATION, including, without limitation, the repayment of all indebtedness, liabilities and obligations owing by the Debtors to the Secured Party (the receipt and sufficiency of which consideration is hereby acknowledged by the Secured Party) pursuant to a Payout Letter executed on September 12, 2018, the Secured Party does hereby absolutely and unconditionally release and forever discharge all security granted by the Debtors in favour of the Secured Party pursuant to the Existing Credit Agreement, including, without limitation, all Patents and Trademarks as set forth in Schedule "A" and Schedule "B". The Secured Party further releases all of its right, title and interest in and to the intellectual property, assets and collateral secured, hypothecated or pledged under or by the Existing Credit Agreement. All agreements, documents or other instruments evidencing or comprising the Existing Credit Agreement are hereby cancelled and terminated and are of no further force or effect.



The Secured Party authorizes and directs counsel or other agents for the Secured Party or the Debtor to file this Release and Discharge with CIPO and the USPTO.


