TERMINATION AND RELEASE OF SECURITY INTEREST IN TRADEMARKS

This TERMINATION AND RELEASE OF SECURITY INTEREST IN TRADEMARKS (this “Release”), dated as of October 3, 2022 (the “Effective Date”), is made by Bank of America, N.A., in its capacity as Collateral Agent (the “Agent”), in favor of Change Healthcare Resources, LLC (formerly known as Altegra Health Operating Company LLC), a Delaware limited liability company, Change Healthcare Solutions, LLC, a Delaware limited liability company, Change Healthcare Engagement Solutions, Inc., a Delaware corporation, Change Healthcare Operations, LLC, a Delaware limited liability company, Change Healthcare Technologies, LLC (formerly known as McKesson Technologies LLC), a Delaware limited liability company, Change Healthcare Practice Management Solutions Group, Inc. (formerly known as Med3000 Group, Inc.), a Delaware corporation, Change Healthcare HealthQx, LLC (formerly known as HealthQx, LLC), a Pennsylvania limited liability company, and Change Healthcare Management Company, LLC (formerly known as Pediatric Health Alliance, L.L.C.), a Delaware limited liability company (each individually, a “Grantor”, and collectively, the “Grantors”). All capitalized terms used, but not otherwise defined herein, shall have the respective meanings ascribed in or otherwise referenced in the Security Agreement (as defined below) or the Trademark Security Agreement (as defined below), as applicable.

WHEREAS, pursuant to that certain Security Agreement, dated as of March 1, 2017, by and among the Agent, the Grantors and certain other parties thereto (as amended, amended and restated, supplemented or otherwise modified from time to time, the “Security Agreement”), the Grantors granted to the Agent, in its capacity as Agent, a security interest in and to certain Collateral, including Trademarks;

WHEREAS, pursuant to the Security Agreement, the Grantors executed and delivered a Trademark Security Agreement, dated as of March 1, 2017 (the “Trademark Security Agreement”), which was recorded with the United States Patent and Trademark Office on March 2, 2017 at Reel/Frame 5999/0301, pursuant to which each Grantor pledged and granted to the Agent a lien on and security interest in and to all of its right, title and interest in, to and under all registered Trademarks and Trademarks with respect to which applications for registration are pending of such Grantor listed on Schedule 1 attached hereto, in each case, excluding any Excluded Assets (collectively, the “Trademark Collateral”); and

WHEREAS, the Agent wishes to release, discharge, terminate and cancel all liens and security interests created by the Trademark Security Agreement in and to the Trademark Collateral, restore all right, title and interest in and to the Trademark Collateral to the Grantors and terminate the Trademark Security Agreement.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Agent hereby agrees as follows:

1. Release. The Agent hereby irrevocably releases, discharges, terminates and cancels any and all liens and security interests it has in and to the Trademark Collateral, arising under the Security Agreement and the Trademark Security Agreement, and any right, title or interest of the Agent in the Trademark Collateral shall hereby cease and become void. If and to the extent that the Agent has acquired any right, title or interest in and to the Trademark Collateral under the Security Agreement or the Trademark Security Agreement, as applicable, the Agent, without representation or warranty of any kind, hereby irrevocably transfers, conveys and assigns such right, title or interest to the Grantors.

2. Termination. The Agent hereby irrevocably terminates and cancels the Trademark Security Agreement.


3. Further Assurances. The Agent agrees to take all further actions, and provide to the Grantors and their successors, assigns or other legal representatives, all such cooperation and assistance (including, without limitation, the execution and delivery of any and all documents or other instruments), reasonably requested by the Grantors, at the Grantors' sole cost and expense, to more fully and effectively effectuate the purposes of this Release. The Agent hereby authorizes and requests that the Commissioner for Trademarks of the United States Patent and Trademark Office record this Release.

4. Governing Law. This Release, and all disputes between the parties under or relating to this Release, shall be governed exclusively under the laws of New York, without regard to conflicts of law or choice of law principles.

5. Counterparts. This Release may be executed in counterparts (and by different parties hereto in different counterparts), each of which shall constitute an original, but all of which when taken together shall constitute a single contract. Delivery of an executed counterpart of a signature page of this Release by facsimile or other electronic imaging (including in .pdf format) means shall be effective as delivery of a manually executed counterpart of this Release. This Release may be in the form of an Electronic Record (as defined in 15 USC §7006, as it may be amended from time to time) and may be executed using Electronic Signatures (as defined in 15 USC §7006, as it may be amended from time to time) (including, without limitation, facsimile and .pdf) and shall be considered an original, and shall have the same legal effect, validity and enforceability as a paper record. For the avoidance of doubt, the authorization under this paragraph may include, without limitation, use or acceptance by the parties hereto of a manually signed paper counterpart to this Release which has been converted into electronic form (such as scanned into PDF format), or an electronically signed counterpart to this Release converted into another format, for transmission, delivery and/or retention.
