**RELEASE OF SECURITY INTEREST IN INTELLECTUAL PROPERTY**  
**(FIRST LIEN)**

This RELEASE OF INTELLECTUAL PROPERTY SECURITY AGREEMENT (FIRST LIEN) (this “Release”) is entered into as of September 30, 2022 by CREDIT SUISSE AG, CAYMAN ISLANDS BRANCH, a Swiss bank with offices located at 11 Madison Avenue, New York, New York 10010, as Administrative Agent for the Secured Parties (the “Assignor”), in favor of CARESTREAM HEALTH, INC., a Delaware corporation (the “Borrower”), and each of the Guarantors set forth below (together with the Borrower, the “Assignees” and each, an “Assignee”). Capitalized terms used in this Release but not defined herein shall have the respective meanings ascribed to such terms in the First Lien Security Agreement or the First Lien IP Security Agreements, as applicable.

**WHEREAS**, reference is made to that certain (i) Amended and Restated Credit Agreement (First Lien), dated as of June 7, 2013 (as amended pursuant to the First Amendment to Amended and Restated Credit Agreement (First Lien), dated as of June 9, 2017, the Second Amendment to Amended and Restated Credit Agreement (First Lien), dated as of June 22, 2017, the Third Amendment to Amended and Restated Credit Agreement (First Lien), dated as of December 27, 2018, the Guarantor Joinder Agreement & Amendment to Amended and Restated Credit Agreement (First Lien), dated as of April 11, 2019, the Fourth Amendment to Amended and Restated Credit Agreement (First Lien), dated as of January 29, 2020, the Extension Agreement (First Lien), dated as of April 13, 2020, the Fifth Amendment to Amended and Restated Credit Agreement (First Lien), dated as of May 8, 2020, the Sixth Amendment to Amended and Restated Credit Agreement (First Lien), dated as of October 14, 2020 and as may be further amended, modified, extended, restated, replaced, or supplemented prior to the date hereof, the “First Lien Credit Agreement”) by and among Carestream Health Holdings, Inc. (“Holdings”), the Borrower, the Guarantors (as defined therein) party thereto, the lenders from time to time party thereto and the Assignor; (ii) Amended and Restated Pledge and Security Agreement (First Lien), dated as of June 7, 2013 (as amended, supplemented, replaced or otherwise modified prior to the date hereof, the “First Lien Security Agreement”), made by the Assignees and the other Grantors (as defined therein) party thereto in favor of the Assignor; (iii) Amended and Restated Intellectual Property Security Agreement (First Lien) dated as of June 7, 2013 (the “2013 IP Security Agreement”) made by the Borrower and the other Grantors (as defined therein) party thereto in favor of the Assignor; (iv) Confirmatory Grant of Security Interest in Intellectual Property (First Lien), dated January 14, 2019 (the “2019 IP Security Agreement”), made by the Borrower, Assignor and the Assignees, to evidence the After-Acquired IP (as defined in the 2019 IP Security Agreement) as part of the IP Collateral; and (v) Confirmatory Grant of Security Interest in Intellectual Property (First Lien), dated May 8, 2020 (the “2020 IP Security Agreement”), by the Assignor and the Borrower, to evidence the After-Acquired IP (as defined in the 2020 IP Security Agreement) as part of the IP Collateral (the 2013 IP Security Agreement, 2019 IP Security Agreement and 2020 IP Security Agreement, collectively, the “First Lien IP Security Agreements”);

**WHEREAS**, pursuant to the terms and conditions of the First Lien IP Security Agreements, each Assignee collaterally assigned, granted, mortgaged and pledged to the Assignor and granted to the Assignor, for the ratable benefit of the Secured Parties, a security interest in all of the following property then owned or at any time thereafter acquired by such Assignee or in which such Assignee then had or at any time in the future may acquire any right, title or interest

(collectively, the “IP Collateral”), as collateral security for the prompt and complete payment and performance when due (whether at the stated maturity, by acceleration or otherwise) of the Obligations (including, without limitation, any extensions, modifications, substitutions, amendments or renewals of any or all of the Obligations):

(a) (i) all U.S., State and foreign trademarks, trade names, corporate names, company names, business names, domain names, fictitious business names, trade styles, service marks, certification marks, collective marks, logos and other source or business identifiers, designs and general tangibles of a like nature of any Assignee, all registrations and recordings thereof, and all applications in connection therewith, whether in the United States Patent and Trademark Office or in any similar office or agency of the United States, any State thereof or any other country or any political subdivision thereof, or otherwise, and all common-law rights related thereto, including, without limitation, any of the foregoing referred to on Schedule I hereto, and all rights corresponding thereto throughout the world, (ii) all of the goodwill of the business connected with the use of and symbolized by the foregoing; (iii) all extensions and renewals of the foregoing, (iv) the right to sue for past, present and future infringements or dilution of any of the foregoing or for any injury to goodwill, and (v) all proceeds of the foregoing, including, without limitation, licenses, royalties, income, payments, claims, damages, and proceeds of suit (collectively, the “Trademarks”);

(b) all written or oral agreements naming any Assignee as licensor or licensee (including, without limitation, those listed on Schedule I hereto) granting any right in or to any Trademark;

(c) (i) all United States and foreign patents and applications for letters patent of any Assignee throughout the world, including, but not limited to, any of the foregoing referred to on Schedule I hereto, and all rights corresponding thereto throughout the world, (ii) all reissues, divisions, continuations, continuations-in-part, extensions, renewals, and reexaminations of any of the foregoing; (iii) the right to sue for past, present and future infringements of any of the foregoing, and (iv) all proceeds of the foregoing, including, without limitation, licenses, royalties, income, payments, claims, damages, and proceeds of suit (collectively, the “Patents”);

(d) all written or oral agreements naming any Assignee as licensor or licensee (including, without limitation, those listed on Schedule I hereto) granting any right under any of the Patents, including, without limitation, the right to manufacture, use or sell any invention covered in whole or in part by a Patent;

(e) (i) all copyrights of any Assignee arising under the laws of the United States, any other country or any political subdivision thereof, whether registered or unregistered and whether published or unpublished (including, without limitation, those listed on Schedule I hereto), all registrations and recordings thereof, and all applications in connection therewith, including, without limitation, all registrations, recordings and applications in the United States Copyright Office, (ii) the right to obtain all renewals thereof, and (iii) all proceeds of the foregoing, including, without limitation, licenses, royalties, income, payments, claims, damages, and proceeds of suit (collectively, the “Copyrights”);

(f) (i) all mask works fixed in semi-conductor chip products (as defined under 17 U.S.C. 901 of the U.S. Copyright Act), (ii) the right to obtain all renewals thereof, and (iii) all rights to sue at law or in equity for any infringement or other impairment thereof, including the right to receive all proceeds and damages therefrom and all payments and royalties arising out of the sale, lease, license, assignment or other disposition thereof; and all written or oral agreements naming any Assignee as licensor or licensee (including, without limitation, those listed on Schedule I hereto), granting any right under any Copyright or mask work, including, without limitation, the grant of rights to manufacture, distribute, exploit and sell materials derived from any Copyright or mask work in the foregoing paragraphs (e) and (f);

**WHEREAS**, (i) the First Lien Intellectual Property Security Agreement was recorded with (a) the United States Patent and Trademark Office on June 28, 2013 at Reel 030711, Frame 0648, (b) the United States Patent and Trademark Office on June 28, 2013 at Reel 5059, Frame 0023 and (c) the United States Copyright Office on July 1, 2013 at Volume 9912, Document No. 659; (ii) the 2019 IP Security Agreement was recorded with (a) the United States Patent and Trademark Office on January 15, 2019 at Reel 048077, Frame 0529, (b) the United States Patent and Trademark Office on January 15, 2019 at Reel 006525, Frame 0499 and (c) the United States Copyright Office on January 16, 2019 at Volume 9965, Document No. 897; and (iii) the 2020 IP Security Agreement was recorded with the United States Patent and Trademark Office on May 8, 2020 at Reel 052611, Frame 0049;

**WHEREAS**, pursuant to that certain Release of Security Interest in Specified Intellectual Property (First Lien) (the “2017 Partial Release”), the Assignor released Specified IP Collateral (as defined in the 2017 Partial Release), and the 2017 Partial Release was recorded with (a) the United States Patent and Trademark Office on September 1, 2017 at Reel 043749, Frame 0133, (b) the United States Patent and Trademark Office on September 1, 2017 at Reel 006146, Frame 0600 and (c) the United States Copyright Office on September 1, 2017 at Volume 9950, Document No. 656;

**WHEREAS**, pursuant to that certain Partial Release of Security Interest in Intellectual Property (First Lien) (the “2019 Partial Release”), the Assignor released the Released Collateral (as defined in the 2019 Partial Release); and

**WHEREAS**, the Borrower has requested and the Assignor has agreed to terminate and release its security interest in the IP Collateral, and the Assignor has agreed to execute this Release as evidence of such release.

**NOW, THEREFORE**, for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, the Assignor hereby terminates, releases and discharges fully, without representation, warranty or recourse, its security interest in and continuing lien on all of each Assignee’s right, title and interest in, to and under the IP Collateral (including, without limitation, such IP Collateral as is listed on Schedule I hereto), and any right, title or interest of the Assignor in the IP Collateral shall hereby cease and become void. The Assignor, without representation, warranty or recourse, hereby terminates and cancels the First Lien IP Security Agreements.

The Assignor hereby authorizes the Assignees or the Assignees' authorized representative to record this Release with the United States Patent and Trademark Office and the United States Copyright Office.

The Assignor shall execute and deliver any and all documents or other instruments reasonably requested by the Assignees, and at the Assignees' sole cost and expense, to more fully and effectively effectuate the purposes of this Release.

**THIS AGREEMENT SHALL BE GOVERNED BY, AND SHALL BE CONSTRUED AND INTERPRETED IN ACCORDANCE WITH, THE LAWS OF THE STATE OF NEW YORK.**
