Please be advised that pursuant to the Third Amended and Restated Collateral Agreement dated as of October 19, 2022 (as amended, restated, amended and restated, extended, replaced, supplemented or otherwise modified in writing from time to time, the "Agreement") among the undersigned Grantor, the other grantors party thereto and the Administrative Agent (including any successors and permitted assigns) for the Secured Parties referenced in the Agreement, the undersigned Grantor has granted a continuing security interest in and continuing lien upon the Trademarks identified on Schedule 1 hereto, including the associated goodwill (the "Trademark Collateral") to the Administrative Agent for the ratable benefit of the Secured Parties. The Grantor does hereby acknowledge and confirm that the grant of the security interest hereunder to, and the rights and remedies of, the Administrative Agent with respect to the Trademark Collateral are more fully set forth in the Agreement, the terms and provisions of which are incorporated herein by reference as if fully set forth herein.




