## TRADEMARK ASSIGNMENT AGREEMENT

WHEREAS, Assignee desires to acquire from Assignor all right, title and interest in and to the Marks;



Assignor authorizes the Commissioner for Trademarks in the United States Patent and Trademark Office and the officials of corresponding entities or agencies in any applicable jurisdictions to record and register this Trademark Assignment upon request by Assignee.

This Trademark Assignment may be executed in counterparts, each of which shall be deemed an original, but all of which together shall constitute one and the same instrument. Further, this assignment may be executed by electronic transmission (e.g. a .pdf file containing an electronic signature), and such signature shall have the same force and effect as an original signature.


