**TERMINATION AND RELEASE OF
FIRST LIEN SECURITY INTEREST IN TRADEMARKS**

This Termination and Release of First Lien Security Interest in Trademarks (“Release”) is made as of October 6, 2022, by **UBS AG, STAMFORD BRANCH** (“Collateral Agent”) in favor of **CPI SATCOM & ANTENNA TECHNOLOGIES INC.**, a Delaware corporation with an address at 1700 Cable Drive NE, Conover, North Carolina 28613 (the “Grantor”).

W I T N E S S E T H:

WHEREAS, the Grantor entered into a certain trademark security agreement dated June 11, 2020 (the “Trademark Security Agreement”) with Collateral Agent, notice of which was recorded on June 12, 2020 at the United States Patent and Trademark Office at Reel 6969, Frame 0708.

Capitalized terms used but not otherwise defined herein have the meanings given to them in the Trademark Security Agreement.

WHEREAS, Grantor granted the Collateral Agent, under the terms of the Trademark Security Agreement, a continuing security interest (the “Security Interest”) in favor of the Collateral Agent, in all of such Grantor’s right, title and interest in, to and under the Trademark Collateral, including the trademarks and trademark applications listed in **Schedule A** (collectively, the “Released Trademark Collateral”).


WHEREAS, the Collateral Agent has agreed to terminate and release its security interest in all such Released Trademark Collateral as herein provided.

NOW, THEREFORE, in consideration of the foregoing and intending to be legally bound, the Collateral Agent hereby releases, terminates and discharges any and all of its interest in the Released Trademark Collateral of the Grantor, and assigns, transfers and conveys to Grantor any interest in such intellectual property, including the Security Interest. If and to the extent that the Collateral Agent has acquired any right, title or interest in and to the Released Trademark Collateral under the Trademark Security Agreement, the Collateral Agent, without representation or warranty of any kind, hereby re-transfers, re-conveys and re-assigns such right, title or interest to the Grantor.
