RELEASE OF SECURITY INTEREST IN TRADEMARKS

This RELEASE OF SECURITY INTEREST IN TRADEMARKS (this “Release”), dated as of October 19, 2022 (the “Effective Date”), is made by Wilmington Trust, National Association (the “Agent”) in favor of Gilsbar, L.L.C., a Louisiana limited liability company (“Gilsbar”) and MedCom Care Management, L.L.C. (“MedCom”).

WHEREAS, MedCom and Gilsbar are grantors party to that certain Security Agreement, dated as of October 27, 2020 (as amended, restated, amended and restated, supplemented or otherwise modified from time to time, the “Security Agreement”; capitalized terms used herein but not otherwise defined herein have the meanings ascribed to them in the Security Agreement), among MedCom, Gilsbar, the other grantors party thereto from time to time and Wilmington Trust, National Association, as Administrative Agent and Collateral Agent, pursuant to which each grantor, including MedCom and Gilsbar, granted a security interest to the Administrative Agent in the Collateral;

WHEREAS, pursuant to terms of the Security Agreement, each of MedCom and Gilsbar executed and delivered that certain Trademark Security Agreement, dated as of March 25, 2022 (as amended, restated, amended and restated, supplemented or otherwise modified from time to time, the “Trademark Security Agreement”), pursuant to which MedCom and Gilsbar granted a security interest to the Administrative Agent in the Trademark Collateral (as defined below);

WHEREAS, such security interests were recorded with the United States Patent and Trademark Office at the Reel/Frame 7685/0917 on March 25, 2022;

WHEREAS, MedCom and Gilsbar executed that certain Trademark Assignment, dated as of July 26, 2022 (the “Trademark Assignment”), pursuant to which MedCom and Gilsbar assigned certain Trademarks to Gilsbar Holdings, L.L.C.;

WHEREAS, the Agent has agreed to release, discharge, terminate and cancel its security interest in certain specified collateral;

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Agent hereby agrees as follows.


1. Release of Specified Collateral. The Agent, without representation or warranty of any kind, hereby releases, discharges, terminates and cancels any and all of its liens on and security interest in and to the trademark registrations and applications set forth on Schedule I (the “Released Trademark Collateral”). If and to the extent the Agent has acquired any right, title or interest in and to the Released Trademark Collateral, the Agent, without representation or warranty of any kind, hereby re-transfers, re-conveys and re-assigns all such right, title or interest to MedCom and Gilsbar, as applicable, and their successors or assigns.
2. Limitation. This Release is applicable only and solely with respect to the Released Trademark Collateral and to no other Collateral.
3. Further Assurances. The Agent agrees to take all further actions, and provide to MedCom and Gilsbar, as applicable, and their successors, assigns or other legal representatives, all such cooperation and assistance (including, without limitation, the execution and delivery of any and all documents or other instruments), reasonably requested by the MedCom or Gilsbar, as applicable, at MedCom or Gilsbar’s sole cost and expense, as applicable, to more fully and effectively effectuate the purposes of this Release.

4. Governing Law. This Release shall be governed exclusively under the laws of the State of New York, without regard to conflicts of law or choice of law principles.
