**ASSET DISTRIBUTION AGREEMENT**

This **ASSET DISTRIBUTION AGREEMENT** (the “**Agreement**”), dated as of July 20, 2022 (the “**Effective Date**”), is entered into by and between TelevisaUnivision Interactive, LP, a Delaware limited partnership (formerly known as Univision Digital IP Holdings, LLC) (the “**Transferor**”) and Univision Communications Inc., a Delaware corporation (the “**Transferee**”). Transferor and Transferee are collectively referred to herein as a “**Party**” and collectively, as the “**Parties**”.

**RECITALS**

**WHEREAS**, Transferor owns all of the Transferred Assets (as defined below); and

**WHEREAS**, Transferor desires to transfer, convey, assign and deliver to Transferee, and Transferee desires to acquire and accept from Transferor, all of Transferor’s right, title and interest in and to all of the trademarks owned by Transferor that do not relate to the ViX business of TelevisaUnivision, Inc., including those trademarks listed on Schedule A and any related property (the “**Transferred Assets**”), in each case, in the form of a distribution by the Transferor to the Transferee in its capacity as a limited partner of the Transferor.

**NOW, THEREFORE**, in consideration of the mutual covenants and agreements set forth in this Agreement, and for other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Parties agree as follows:

1. **Transfer**. Upon the terms and subject to the conditions of this Agreement, effective as of the date hereof, Transferor hereby distributes, transfers, conveys, assigns and delivers to the Transferee, and Transferee hereby receives and acquires, all right, title and interest worldwide in and to the Transferred Assets, without payment of cash consideration on account of its partnership interest in the Transferor, including, without limitation, (i) all common law rights, registrations and applications therefor, (ii) all goodwill associated with and symbolized thereby, and (iii) all claims that Transferor might have with respect thereto, at law or in equity, including the right to sue and recover damages for past, present and future infringement thereof. As of the date of transfer, the Parties agree that all right, title, interest and obligations with respect to the Transferred Assets are transferred from the Transferor to the Transferee. Transferee acknowledges and agrees that as a result of the foregoing, its ownership interest in the Transferor shall be 96.78% of the limited partnership interest.

2. **Representations and Warranties**. No Party makes any representations or warranties under or with respect to this Agreement. The Transferee expressly acknowledges and agrees that the Transferred Assets are transferred, conveyed, assigned and delivered on an “as is, where is and with all faults” basis.

3. **Further Assurances**. Each of the Parties agrees that it will take such actions and execute such additional documents as may be reasonably requested by the other Parties in order to effectuate more fully the purposes and intent of this Agreement.

4. **Authorization**. The Parties hereby authorize and request the relevant authority at the United States Patent and Trademark Office or any foreign equivalent thereto to record this Agreement.

5. **Governing Law.** This Agreement shall be governed by and construed in accordance with and subject to the laws of the State of Delaware without giving effect to the principles of conflicts of law thereunder, regardless of the laws that might otherwise govern under applicable principles of conflicts of laws thereof.

6. **Notices.** All notices and communications between the Parties shall be sent by air mail, postage prepaid, international courier, electronic mail or facsimile, addressed to the Party at its current address. All notices and communications shall be deemed received (i) if sent by registered air mail or international courier, five (5) days after the date of mailing; and (ii) if sent by electronic mail or facsimile, twenty-four (24) hours after the time and date of transmission.

7. **Severability.** If any provision of this Agreement shall be found or held to be invalid or unenforceable in any jurisdiction in which this Agreement is being performed, the remainder of the Agreement shall be valid and enforceable and the Parties shall negotiate in good faith or a court with proper jurisdictions shall fashion a substitute, valid and enforceable provision which most nearly effects the Parties' intent in entering this Agreement. Any provision which contravenes applicable laws, rules or regulations of any jurisdiction in which the Parties are located, shall be deemed severable and of no force or effect and shall not affect the validity or enforceability of any other provision of this Agreement which shall remain valid and enforceable in accordance with its terms.

8. **Headings.** The subject headings of this Agreement are included for purposes of convenience only, and shall not affect the construction or interpretation of any provision of this Agreement.

9. **Counterparts.** This Agreement may be executed in several duplicates, each of which shall be deemed an original, but all of which together shall constitute one and the same instrument.

10. **No Third Party Beneficiaries.** This Agreement is not intended to confer upon any other person or entity other than the Parties any rights or remedies hereunder.

11. **Entire Agreement and Amendments.** This Agreement constitutes the entire agreement between the Parties, and terminates and supersedes all prior agreements, understandings and communications between the Parties with respect to the subject matter hereof. No modification or amendment to this Agreement shall be binding upon the Parties unless in writing and executed by the duly authorized representative of each of the Parties.


