**RELEASE OF SECURITY INTEREST IN UNITED STATES  
TRADEMARK**

THIS RELEASE OF SECURITY INTEREST IN UNITED STATES TRADEMARK (this “*Release*”) is made as of September 21, 2022, by FEAC AGENT, LLC, a Delaware limited liability company (“*FEAC*”), in its capacity as collateral agent for the benefit of the Secured Parties (in such capacity, together with its successors and permitted assigns, the “*Collateral Agent*”), in favor of IMAGEQUIX, LLC (“*Grantor*”). Capitalized terms used but not otherwise defined herein have the meanings given to them in the Trademark Security Agreement (defined below).

WITNESSETH:

WHEREAS, pursuant to that certain Trademark Security Agreement, dated as of November 5, 2021, by the Grantor in favor of the Collateral Agent (the “*Trademark Security Agreement*”), the Grantor mortgaged and pledged to the Collateral Agent for the benefit of the Secured Parties, and granted to the Collateral Agent for the benefit of the Secured Parties a Lien on and a security interest in, all of its right, title and interest in, to and under all of the Trademark Collateral of such Grantor including the Trademarks and Trademark Licenses specifically listed on Schedule A attached hereto (the Trademarks and Trademark Licenses identified on Schedule A hereto, the “*Released Trademarks*”);

WHEREAS, the Trademark Security Agreement was recorded with the United States Patent and Trademark Office on November 9, 2021 at Reel 7488, Frame 0781; and

WHEREAS, Collateral Agent now desires to terminate and release its lien on and security interest in and to the Released Trademarks and reassign and retransfer to the Grantor all of the Collateral Agent’s rights, title and interest in and to the Released Trademarks.

NOW, THEREFORE, for good and valuable consideration, receipt and sufficiency of which are hereby acknowledged, the Collateral Agent, for the benefit of the Secured Parties, hereby agrees as follows:

1. Collateral Agent hereby terminates and releases its security interest in and to (i) the Released Trademarks providing for the grant by or to such Grantor of any right under any Trademark, (ii) all renewals and extensions of the foregoing, (iii) all goodwill of the business connected with the use of, and symbolized by, each such Released Trademark, and (iv) all income, royalties, proceeds and liabilities at any time due or payable or asserted under and with respect to any of the foregoing, including all rights to sue and recover at law or in equity for any past, present and future infringement, misappropriation, dilution, violation or other impairment thereof. If and to the extent that Collateral Agent has acquired any right, title or interest in, to or under any of the foregoing, it hereby reassigns, grants and conveys to the Grantor, without any representation, warranty, recourse or undertaking by Collateral Agent, any and all of Collateral Agent’s right, title, and interest in and to the foregoing.

2. Nothing contained in this Release shall be construed as a termination, release, retransfer or reassignment of any security interest, if any, or any right, title and interest

which the Collateral Agent may have in the Trademark Collateral, as defined in the Trademark Security Agreement, which has not been specifically identified on Schedule A.


3. This Release and the rights and obligations of the parties hereunder shall be governed by, and shall be construed and enforced in accordance with, the laws of the State of New York without regard to conflict of laws principles thereto.

4. The Collateral Agent authorizes that this Release can be recorded with the United States Patent and Trademark Office.
