**CERTIFICATE OF AMENDMENT
OF
THE CERTIFICATE OF INCORPORATION
OF
TCP RELIABLE, INC.**

Pursuant to the provisions of Title 14A, Chapter 9 of the New Jersey Business Corporation Act (the “**BCA**”), the undersigned corporation adopts the following Certificate of Amendment to its Certificate of Incorporation (the “**Certificate of Amendment**”).

1. The name of the corporation is: TCP RELIABLE, INC. (the “**Corporation**”).
2. The following amendments to the Certificate of Incorporation of the Corporation (the “**Certificate of Incorporation**”) were approved by the directors and thereafter duly adopted by the shareholders of the Corporation on June 22, 2020:

RESOLVED, that Article FIRST of the Certificate of Incorporation be amended and restated in its entirety to read as follows:

FIRST: The name of the corporation (hereinafter called the “Corporation”) is:

INTEGREON GLOBAL, INC.

RESOLVED, that Article FOURTH of the Certificate of Incorporation be amended and restated in its entirety to read as follows:

FOURTH: The address of the registered office of the corporation within the State of New Jersey is 830 Morris Turnpike, Suite 402, Short Hills, NJ 07078; and the name of the registered agent at such address is Celine Barakat, Corporate Affairs Director and Legal Counsel.

3. The number of shares outstanding at the time of the adoption of the foregoing amendment was 7,665. The total number of shares entitled to vote thereon was 7,665.
4. The number of shares voting for and against such amendment is as follows:
