TERMINATION AND RELEASE OF  
SECURITY INTEREST IN U.S. TRADEMARKS

This **TERMINATION AND RELEASE OF SECURITY INTEREST IN U.S. TRADEMARKS** (this “Release Agreement”), dated as of October 18, 2022 is made by **BANK OF AMERICA, N.A.**, a national banking association, as Agent (the “Grantee”) in favor of **TARGUS INTERNATIONAL LLC**, a Delaware limited liability company, **TARGUS US LLC**, a Delaware limited liability company, **SENA CASES LLC**, a Delaware limited liability company, **TARGUS GROUP US LLC**, a Delaware limited liability company, **TARGUS US SUB I INC.**, a Delaware corporation, **TARGUS US SUB II INC.**, a Delaware corporation, **TARGUS US NEWCO INC.**, a Delaware corporation, **TARGUS (CANADA) LTD.**, a corporation continued under the federal laws of Canada, **TARGUS ASIA PACIFIC LIMITED**, a company incorporated under the laws of Hong Kong, **TARGUS AUSTRALIA PTY LTD**, a company incorporated under the laws of Australia, **TARGUS EUROPE LIMITED**, a company incorporated in England (registered number 01743076), **TARGUS GROUP (UK) LIMITED**, a company incorporated in England (registered number 02989548), **TARGUS INTERNATIONAL HOLDCO (UK) LIMITED**, a company incorporated in England (registered number 07135312), **TARGUS CAYMAN SUBCO LIMITED**, a Cayman Islands exempted company, **TARGUS CAYMAN LP**, a Cayman Islands exempted limited partnership, **TARGUS CAYMAN GP LIMITED**, a Cayman Islands exempted company, **TARGUS CAYMAN HOLDCO LIMITED**, a Cayman Islands exempted company (collectively the “Grantors”).

**WHEREAS**, the Grantors and the Grantee are parties to that certain Amended and Restated Trademark Security Agreement dated as of June 19, 2019 (the “Security Agreement”), whereby the Grantors granted to the Grantee a security interest in the trademarks and trademark applications listed on **Schedule A** attached hereto (the “Trademark Collateral”) for recordation with the United States Patent and Trademark Office; and

**WHEREAS**, the Security Agreement was recorded with the Trademark Division of the United States Patent and Trademark Office on July 17, 2019 at Reel 006696, Frame 0688; and

**WHEREAS**, the Security Agreement was recorded with the Canadian Intellectual Property Office on August 12, 2016; and

**WHEREAS**, the obligations secured by said security interest have been paid in full or otherwise satisfied; and

**WHEREAS**, the Grantee has agreed to terminate and release its security interest and all of its right, title and interest in each of the Trademark Collateral, as herein provided.

**NOW, THEREFORE**, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Grantee hereby agrees as follows:

1. **Definitions.** All capitalized terms used but otherwise not defined herein shall have the meaning ascribed to them in the Security Agreement.

2. **Release and Assignment.** The Grantee hereby irrevocably discharges, terminates and releases the entirety of its security interest in, and hereby irrevocably assigns to the Grantor any other right, title or interest that the Grantee may have in or to the following:

- (a) all Trademark Collateral;
- (b) all extensions or renewals of the foregoing;

- (c) all goodwill of the business connected with the use of, and symbolized by, each item included in the Trademark Collateral;
- (d) the right to sue for past, present and future infringement or dilution of any of the foregoing or for any injury to goodwill; and
- (e) all Proceeds of the foregoing, including, without limitation, licenses, royalties, income, payments, claims, damages and proceeds of suit.

3. **Recordation**. The Grantee hereby authorizes and requests that the U.S. Patent and Trademark Office, the Canadian Intellectual Property Office, and any other applicable intellectual property office note and record the releases and terminations granted under this Release Agreement, and authorizes any other filings necessary to evidence the termination, release and discharge of the Grantee's security interests, liens and other rights granted under the Security Agreement with respect to the Trademark Collateral.

4. **Further Assurances**. The Grantee hereby agrees to execute, acknowledge and deliver all such further instruments and to take all such further actions as may be reasonably requested or are required in order to more fully and effectively carry out the purposes of this Release Agreement at the Grantors' sole cost and expense.

5. **Governing Law**. This Release Agreement and the rights and obligations of the parties hereunder shall be governed by, and shall be construed and enforced in accordance with, the laws of the State of California.
