TRADEMARK RELEASE

WHEREAS, pursuant to a certain security agreement made as of March 18, 2011 between Moog Inc. (“Debtor”) in favor of HSBC Bank USA, National Association, as administrative agent for the benefit of certain lenders and for its benefit as agent (“Secured Party”), which amended and restated an agreement between Debtor and Secured Party dated October 25, 2006, which amended and restated an agreement between Debtor and HSBC Bank USA dated March 3, 2003, and, which agreement was reaffirmed pursuant to the Reaffirmation Agreements dated as of March 28, 2013, June 28, 2016, and October 15, 2019 (“Security Agreement”), the Debtor granted a security interest to Secured Party in several trademarks and trademark applications owned by the Debtor, including the trademarks listed on Schedule A attached hereto (“Trademarks”), and a Notice of Security Interest in Trademarks dated March 18, 2011 was recorded with the United States Patent and Trademark Office (“USPTO”) at reel 004502 and frame 0375-0392 on March 22, 2011, and a Patent, Copyright and Trademark Security Agreement dated July 8, 2015 was recorded with the USPTO at reel 005600 and frame 0356-0379 on August 17, 2015, and a Supplemental Notice of Security Interest in Trademarks dated June 28, 2016 was recorded with the USPTO at reel 005837 and frame 0377-0381 on July 21, 2016 with respect thereto.

WHEREAS, Debtor has notified Secured Party that pursuant to a Permitted Disposition under that certain Fifth Amended and Restated Loan Agreement, dated as of October 15, 2019 (as amended through the date hereof, and as may be further amended, supplemented, extended, renewed, replaced, restated or otherwise modified from time to time) by and between Debtor and Secured Party, certain assets of Debtor are being transferred and in accordance with its agreements with the Secured Party, has requested a release of the collateral owned by Debtor from the Security Agreement.

NOW THEREFORE, Secured Party does hereby release any and all interests in the Trademarks. The foregoing limited release applies only to the Trademarks. Secured Party’s security interest in the various other trademarks and trademark applications owned by the Debtor shall continue in all respects and is hereby ratified and confirmed in its entirety.
