TERMINATION AND RELEASE OF SECURITY INTEREST IN TRADEMARKS

This **TERMINATION AND RELEASE OF SECURITY INTEREST IN TRADEMARKS**, dated as of October 12, 2022 (“Release”), is made by Deerpath Fund Services, LLC, a Delaware limited liability company, as administrative agent and collateral agent (“Agent”), in favor of Ninjio, LLC, a Delaware limited liability company (“Debtor”).

WHEREAS, pursuant to that certain Security Agreement dated as of July 15, 2021 (as amended, restated or supplemented from time to time, the “Security Agreement”) by and among the Debtor, Agent, and others party thereto and the Trademark Security Agreement dated as of July 15, 2021 (“Trademark Security Agreement”) by and among the Debtor and Agent, Debtor mortgaged, pledged and granted to the Agent, for the ratable benefit of the Lenders, a continuing security interest in, and lien on, all IP Collateral; and

WHEREAS, the Trademark Security Agreement was recorded at the United States Patent and Trademark Office (“USPTO”) on August 3, 2021 at Reel 7377 Frame 0307.

NOW THEREFORE, in consideration of the mutual promises and undertakings set forth herein and for other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, and with the intention of being legally bound hereby, Agent, on behalf of the Lenders, and Debtor agree as follows:

SECTION 1. Defined Terms. Capitalized terms used herein without definition shall have the meanings ascribed to such terms in the Security Agreement or Trademark Security Agreement.

SECTION 2. Termination and Release. Agent, on behalf of the Lenders, hereby:

- (a) terminates the Trademark Security Agreement;
- (b) terminates, cancels, forever discharges, and releases the continuing security interest in, and lien on, all IP Collateral, including, but not limited to, the foregoing listed on Schedule A attached hereto;
- (c) represents and warrants that it has full authority to execute and deliver this Release; and
- (d) authorizes the recordation of this Release with the USPTO at Debtor’s expense.

SECTION 3. Further Assurances. Agent, at Debtor’s expense, hereby agrees to duly execute, acknowledge, procure and deliver any further documents and to do such other acts as may be reasonably necessary to effect the security interest release contemplated herein. To the extent that any other filings with any other governmental authority have been made with respect to any of the IP Collateral, Agent will, at Debtor’s expense, execute and deliver a reasonable release or other instrument that will terminate any such filing and/or release any interests conveyed therein.

IN WITNESS WHEREOF, the Agent, on behalf of the Lenders, has caused this Termination and Release of Security Interest in Trademarks to be duly executed as of the date first set forth above.
