**TERMINATION AND RELEASE OF SECURITY INTEREST
IN TRADEMARKS**

This **TERMINATION AND RELEASE OF SECURITY INTEREST IN TRADEMARKS**, dated as of November 1, 2022 (“Release”), is made by Ares Capital Corporation, as Administrative Agent (“Administrative Agent”) in favor of Consumer Safety Technology, LLC, a Delaware limited liability company (“Grantor”).

WHEREAS, pursuant to that certain Guarantee and Collateral Agreement dated as of March 1, 2017 (as amended, supplemented, modified, extended or restated from time to time, the “Collateral Agreement”) by and among the Grantor, Administrative Agent, and others party thereto, Grantor granted to the Administrative Agent, for the benefit of the Secured Parties, a security interest in all of the Grantor’s right, title and interest in and to all its right, title and interest in, to and under the Trademark Collateral; and

WHEREAS, pursuant to the Collateral Agreement, Grantor executed and delivered to Administrative Agent a Trademark Security Agreement dated as of October 4, 2019 between Grantor and Administrative Agent (the “TMSA”), which was recorded in the records of the United States Patent and Trademark Office on October 4, 2019 at reel 6764 and frame 0252.

NOW THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Administrative Agent, on behalf of the Secured Parties, and Grantor agree as follows:

SECTION 1. Defined Terms. All capitalized terms used herein but not otherwise defined herein have the meanings given to them in the Collateral Agreement or the TMSA.

SECTION 2. Termination and Release. Administrative Agent, on behalf of itself and the other Secured Parties, without any representation, warranty, recourse, or undertaking of any kind (whether express or implied), hereby:

(a) terminates, cancels, discharges, and releases the security interest in all of the Grantor’s right, title and interest in and to all its right, title and interest in, to and under the Trademark Collateral, including, but not limited to, the foregoing listed on Schedule A attached hereto, granted pursuant to the Collateral Agreement or the TMSA; and

(b) authorizes the recordation of this Release with the United States Patent and Trademark Office at Grantor’s expense, to the extent applicable.

SECTION 3. Choice of Law. This Release shall be governed by and construed in accordance with the laws of the State of New York.

IN WITNESS WHEREOF, the Administrative Agent, on behalf of the Secured Parties, has caused this Termination and Release of Security Interest in Trademarks to be duly executed as of the date first set forth above.
