RELEASE OF SECURITY INTEREST IN TRADEMARKS

This RELEASE OF SECURITY INTEREST IN TRADEMARKS (this “Release”), dated as of October 31, 2022 (the “Effective Date”), is made by CERBERUS BUSINESS FINANCE, LLC, a Delaware limited liability company (the “Releasor”), as Agent for the Lender Group, in favor of each of TRULITE GLASS & ALUMINUM SOLUTIONS, LLC, a Delaware limited liability company and TRULITE GLASS COMPANY, LLC, a Delaware limited liability company (each a “Releasee” and collectively, the “Releasees”).

WHEREAS, pursuant to (i) that certain Guaranty and Security Agreement, dated January 20, 2017 (as amended, restated, amended and restated, supplemented or otherwise modified from time to time, the “Security Agreement”), by and among the Releasees, the other Grantors (as defined therein) party thereto and Releasor, each Releasee granted to the Releasor, in its capacity as administrative agent and collateral agent for the Lender Group (as defined therein), a continuing security interest in the Collateral (as defined therein) of such Releasee; and (ii) the Security Agreement, each Releasee executed and delivered the Trademark Security Agreement (as defined below);

WHEREAS, pursuant to that certain Trademark Security Agreement, dated January 20, 2017, recorded in the United States Patent and Trademark Office on January 20, 2017 at Reel 5976, Frame 0479 (the “Trademark Security Agreement”), each Releasee pledged and granted to the Releasor for the benefit of the Releasor and the Lender Group, a continuing security interest in the Trademark Collateral; and

WHEREAS, each Releasee has requested, and Releasor wishes to provide, a document suitable for recording in the United States Patent and Trademark Office for purposes of recording the release, relinquishment and discharge of the Releasor's security interest in the Trademark Collateral.

NOW, THEREFORE, in consideration of and in exchange for good and valuable consideration the receipt and sufficiency of which are hereby acknowledged, Releasor hereby agrees as follows:

1. Defined Terms. All capitalized terms used but not otherwise defined herein have the meanings given to them in the Trademark Security Agreement or the Security Agreement, as applicable.


2. Release of Security Interest. Releasor, on behalf of itself and the members of the Lender Group without representation, warranty or recourse, hereby (i) terminates the Trademark Security Agreement, (ii) releases, relinquishes, terminates, cancels and discharges any lien, security interest, right, title, and interest the Releasor or any member of the Lender Group may have in, to, or under the Trademark Collateral, including, without limitation, the Trademarks listed on Schedule A attached hereto, and (iii) reassigns, transfers and conveys to the respective Releasee, any right, title, or interests the Releasor and any member of the Lender Group may have in, to, or under the Trademark Collateral.

3. Governing Law. This Release and the rights and obligations of the parties hereunder shall be governed by, and construed and enforced in accordance with, the laws of the State of New York.


