RELEASE OF SECURITY INTEREST IN TRADEMARKS

THIS RELEASE OF SECURITY INTEREST IN TRADEMARKS ("Release") is made as of this 31st day of October 2022, by WELLS FARGO CAPITAL FINANCE, LLC, a Delaware limited liability company in its capacity as agent ("Agent"), in favor of TRULITE GLASS COMPANY, LLC, a Delaware limited liability company ("Company"). FOR GOOD AND VALUABLE CONSIDERATION, the receipt and adequacy of which are hereby acknowledged, Agent hereby unconditionally and expressly releases, terminates, and extinguishes its liens on and security interests in the Trademark Collateral, including the Trademarks listed on Schedule A attached hereto and made a part hereof, which liens and security interests were established under and pursuant to that certain Trademark Security Agreement dated December 29, 2014 (the "Trademark Security Agreement") executed by the Company in favor of Agent and recorded with the United States Patent and Trademark Office on December 31, 2014 at Reel/Frame 5432/0780.


The Agent hereby (i) assigns, transfers and conveys all right, title or interest of the Agent in the Trademark Collateral to the Company, and (ii) terminates and cancels the Trademark Security Agreement.

This Release and the rights and obligations of the parties hereunder shall be governed by, and construed and enforced in accordance with, the laws of the State of New York.
