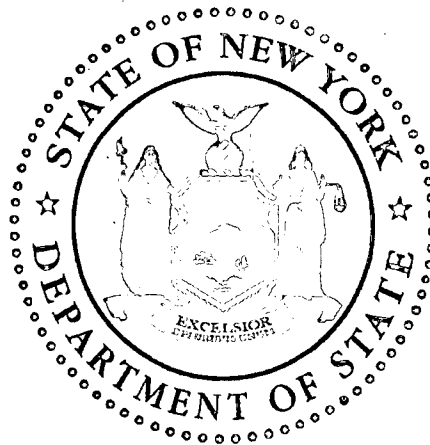

SECOND: The date of the filing of the original certificate of incorporation of the Corporation with the Department of State of the State of New York was January 13, 1969.

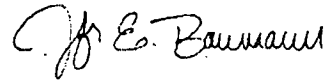
