CERTIFICATE OF AMENDMENT

TO

THIRD AMENDED AND RESTATED CERTIFICATE OF INCORPORATION

OF

RSTUDIO, PBC, A PUBLIC BENEFIT CORPORATION

RStudio, PBC (the “**Corporation**”), a public benefit corporation organized and existing under and by virtue of the General Corporation Law of the State of Delaware (the “**General Corporation Law**”), DOES HEREBY CERTIFY:

FIRST: That the Board of Directors of said Corporation have duly adopted resolutions proposing and declaring advisable that the Third Amended and Restated Certificate of Incorporation, as amended, of the Corporation (the “**Certificate of Incorporation**”) be further amended as follows:

RESOLVED: That the Board recommends and deems it advisable and in the best interests of the Company that the Company’s Third Amended and Restated Certificate of Incorporation, as amended, be further amended by deleting Article FIRST thereof in its entirety and inserting the following new Article FIRST in its place:

“**FIRST:** The name of this corporation is Posit Software, PBC (the “**Corporation**”).”

RESOLVED: That the President of the Company be, and hereby is, authorized and directed to (i) execute, deliver and file a Certificate of Amendment setting forth the aforesaid amendment on behalf of the Company with the Secretary of State of the State of Delaware, the President’s approval to be conclusively evidenced by the execution and delivery of the aforesaid amendment, and (ii) take any and all other actions necessary, desirable or convenient to give effect to the aforesaid amendment or otherwise to carry out the purposes of the foregoing Resolution.

SECOND: That the aforesaid amendment was duly adopted in accordance with the applicable provisions of Section 242 of the General Corporation Law.
