**RELEASE OF SECURITY INTEREST IN TRADEMARKS**

This **RELEASE OF SECURITY INTEREST IN TRADEMARKS** (the “Release”) is made as of October 4, 2022, by GARMARK SBIC ADVISORS II LLC, a Delaware limited liability company, as agent for the Purchasers from time to time a party to the Note Purchase Agreement as defined below (together with its successors and/or assigns, the “Agent”), in favor of PRO-VISION SOLUTIONS, LLC, a Delaware limited liability company (the “Grantee”).

W I T N E S S E T H

WHEREAS, pursuant to (i) that certain Note Purchase Agreement, dated as of August 23, 2019 (as the same may be amended, restated, supplemented and/or otherwise modified from time to time, the “Note Purchase Agreement”), by and among Pro-Vision Midco, LLC, a Delaware limited liability company, and Grantee, the other Note Parties party thereto, and the purchasers from time to time party thereto (the “Purchaser”), and Agent, and (ii) that certain Supplemental Trademark Security Agreement, dated as of August 21, 2020, by Grantee in favor of Agent (the “Trademark Security Agreement”), Grantee granted to Agent a security interest in and continuing lien on all of Grantee’s right, title and interest in, to and under the Trademark Collateral (as defined in the Trademark Security Agreement), including, without limitation, the trademarks and trademark applications identified on Schedule I attached hereto;

WHEREAS, Grantee has requested a release of the Trademark Collateral; and

WHEREAS, Agent, on behalf of itself and the other Purchasers, desires to terminate and grant a release of the Trademark Collateral as provided in this Release.


NOW THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Agent, on behalf of itself and the other Purchasers, does hereby agree as follows:

1. Agent, on behalf of itself and the other Purchasers, hereby (a) terminates the Trademark Security Agreement, (b) releases, relinquishes, terminates and discharges the Trademark Collateral in its entirety and (c) reassigns to Grantee any and all right, title and interest of any nature whatsoever which it may hold in or to the Trademark Collateral (including, without limitation, the trademarks and trademark applications identified on Schedule I attached hereto).
2. Agent, on behalf of itself and the other Purchasers, hereby authorizes the Grantee and its successors, assigns or other legal representatives to file this Release with the U.S. Patent and Trademark Office to evidence and effectuate the release and termination of the Agent’s security interest in the Trademark Collateral.
3. At the reasonable request and sole expense of Grantee, Agent, on behalf of itself and the other Purchasers, agrees to execute, acknowledge and deliver all such further instruments and to take all such further actions necessary to carry out the purposes of this Release.
4. Delivery of an executed signature page of this Release by facsimile or electronic transmission (e.g., email of a PDF file) shall be as effective as delivery of a manually executed counterpart hereof. The words “executed,” “signed,” “signature,” and words of like import in this Release shall be deemed to include electronic signatures or electronic records, each of which shall be of the same legal effect, validity or enforceability as a manually executed signature or the use of a paper-based recordkeeping system, as the case may be, to the extent and as provided for in any applicable law, including the Federal Electronic Signatures in Global and National Commerce Act, the New York State Electronic Signatures and Records Act, or any other similar state laws based on the Uniform Electronic Transactions Act.
