**TERMINATION AND RELEASE OF  
INTELLECTUAL PROPERTY SECURITY AGREEMENT**

THIS TERMINATION AND RELEASE OF INTELLECTUAL PROPERTY SECURITY AGREEMENT (this “Release”) is made as of this 7<sup>th</sup> day of October 2022, by PNC BANK, NATIONAL ASSOCIATION, in its capacity as agent (“Agent”), in favor of NEED IT NOW DELIVERS, LLC, a Delaware limited liability company (“NIND”), FASTMILE DELIVERS, LLC, a Delaware limited liability company (“Fastmile”), and GREENWICH LOGISTICS, LLC, a Delaware limited liability company (“Greenwich”, together with NIND, and Fastmile, each a “Grantor” and collectively the “Grantors”).

WHEREAS, Grantors entered into a certain Intellectual Property Security Agreement, dated June 1, 2018, with Agent, notice of which was recorded with the United States Patent and Trademark Office (“USPTO”) on June 1, 2018, at reel/frame 6375/0504 (the “IP Security Agreement”). Capitalized terms used but not otherwise defined herein have the meanings given to them in the IP Security Agreement.

WHEREAS, Grantors granted to Agent, under the terms of the IP Security Agreement, a continuing security interest in favor of Agent, in and to all their right, title and interest in and to certain intellectual property, including without limitation the intellectual property listed in Schedule I attached hereto (the “IP Collateral”).

WHEREAS, Agent has agreed to terminate and release its security interest in all such IP Collateral as herein provided.

FOR GOOD AND VALUABLE CONSIDERATION, the receipt and adequacy of which are hereby acknowledged, Agent hereby (a) releases, terminates and discharges its security interest in the IP Collateral, including the intellectual property listed on Schedule I attached hereto and made a part hereof, (b) terminates the IP Security Agreement and (c) assigns, transfers and

conveys to Grantors any right, title or interest, including the security interest, it may have in the IP Collateral. Grantors, or any successor to Grantors (including any person or entity hereafter having any right, title or interest in or to the IP Collateral), is hereby authorized to record this Release with the USPTO.
