**RELEASE OF TRADEMARK SECURITY AGREEMENT**

THIS RELEASE OF TRADEMARK SECURITY AGREEMENT (“Release”), dated as of October 3, 2022, is made by Kayne Senior Credit III Loanco, LLC, in its capacity as Administrative Agent for certain lenders (“Agent”), and is as follows:

WHEREAS, Agent and IF&P Foods, LLC a Delaware limited liability company (“Grantor”), are parties to that certain Trademark Security Agreement, dated as of August 15, 2017 (the “IF&P Trademark Agreement No. 1”), which was recorded with The United States Patent and Trademark Office on August 15, 2017, in its records at Reel 6130, Frame 0414.

WHEREAS, Agent and Grantor, are parties to that certain Trademark Security Agreement, dated as of October 6, 2017 (the “IF&P Trademark Agreement No. 2”), which was recorded with The United States Patent and Trademark Office on October 9, 2017, 2017, in its records at Reel 6176, Frame 0593.

WHEREAS, Agent and Grantor, are parties to that certain Trademark Security Agreement Supplement No. 1, dated as of November 18, 2020 (the “Trademark Supplement No. 1” and together with the IF&P Trademark Agreement No. 1 and IF&P Trademark Agreement No. 2, the “Trademark Agreements”), which was recorded with The United States Patent and Trademark Office on December 3., 2020, in its records at Reel 7179, Frame 0954. Capitalized terms used, but not defined, herein shall have the meanings given to them in the Trademark Agreements.

WHEREAS, the Grantor has entered into that certain Pledge and Security Agreement, dated August 15, 2017 (as amended, restated, supplemented or otherwise modified from time to time, the “Security Agreement”) in favor of Agent.

WHEREAS, the Trademark Agreements granted to Agent, for the benefit of the lenders, a continuing security interest in and to all of Grantor’s right, title and interest in and to the trademarks and service marks listed on Schedule I attached hereto and made a part hereof (collectively, the “Trademarks”), together with, among other things, the good-will of the business symbolized by the Trademarks and the applications and registrations thereof, and all proceeds thereof, including, without limitation, any and all causes of action which may exist by reason of infringement thereof and any and all damages arising from past, present, and futures violations thereof (collectively, the “Trademark Rights”); and

WHEREAS, Agent desires to release its rights and security interests in the Trademarks, including each mark, registration, and application listed on Schedule I attached hereto, and each of the other Trademark Rights.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, Agent hereby fully and finally (a), discharges, cancels, releases and terminates its security interest in, Liens on, and all other rights in, to and under the Trademarks, including each mark, registration, and application listed on Schedule I attached hereto, and the

other Trademark Rights, (b) terminates the Trademark Assignments, and (c) re-assigns to the Grantor any and all rights, title and interest it may have in the Trademarks. Agent agrees to take all further actions, and provide to the Grantor and its successors, assigns or other legal representatives, all such cooperation and assistance (including, without limitation, the execution and delivery of any and all documents or other instruments), reasonably requested by the Grantor, at the Grantor's sole cost and expense, to more fully and effectively effectuate the purposes of this Release
