RELEASE OF TRADEMARK SECURITY AGREEMENT

THIS RELEASE OF TRADEMARK SECURITY AGREEMENT dated as of October 17, 2022 (this “**Release**”) is made by ARES CAPITAL CORPORATION, in its capacity as administrative agent (the “**Administrative Agent**”) under that certain Trademark Security Agreement, dated as of August 27, 2019, executed by GREEN STREET ADVISORS, LLC, a Delaware limited liability company (the, “Grantor”), in favor of the Administrative Agent, for the benefit of the Secured Parties (as amended, restated, amended and restated, supplemented or otherwise modified and in effect from time to time, the “**Trademark Security Agreement**”) in favor of the Grantor. All capitalized terms used but not otherwise defined herein have the meanings given to them in the Trademark Security Agreement, the Credit Agreement or Collateral Agreement referenced in the Trademark Security Agreement, as applicable.

WHEREAS, pursuant to the Trademark Security Agreement, the Grantor granted to the Administrative Agent, for the benefit of the Secured Parties, a security interest in, on and to all of such Grantor’s right, title and interest in the Trademark Collateral, including the registered trademarks and trademark applications set forth on the attached Schedule 1; and

WHEREAS, pursuant to that certain Payoff Letter, dated as of October 17, 2022, by and among the Grantor, the Administrative Agent and certain other parties party thereto, the Grantor has requested and the Administrative Agent has agreed to provide a document suitable for evidencing and effecting the release, relinquishment and discharge of its security interest in the Trademark Collateral.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Administrative Agent does hereby, in each case, without recourse, representation or warranty of any kind whatsoever, (a) terminate and cancel the Trademark Security Agreement, (b) terminate the security interest created under each Trademark Security Agreement in the Trademark Collateral, including without limitation the United States registered trademarks and trademark applications set forth on the attached Schedule 1, (c) release its security interest in the Trademark Collateral, (d) discharge any and all rights, title and interest it has in and the security interest granted to the Administrative Agent in the Trademark Collateral, and (e) reassign, grant, and convey all rights and interests Administrative Agent may have in the Trademark Collateral to the Grantor.

Administrative Agent agrees, at the Grantors’ expense, to take all further actions, and provide to the Grantor and its successors, assigns and legal representatives all such cooperation and assistance, including, without limitation, the execution and delivery of any and all further documents or other instruments, as the Grantor and its successors, assigns and legal representatives may reasonably request in order to confirm, effectuate or record this Release.
