**TERMINATION AND RELEASE OF SECURITY INTEREST
IN TRADEMARKS**

This **TERMINATION AND RELEASE OF SECURITY INTEREST IN TRADEMARKS** dated as of October 28, 2022 (“Release”), is made by Fifth Third Bank, as successor in interest to Regions Bank, as Collateral Agent (“Collateral Agent”) for the Secured Parties (as defined herein) in favor of Sabertooth Sports & Entertainment, LLC, a Delaware limited liability company (“Grantor”).

WHEREAS, pursuant to that certain Fourth Amended and Restated Credit Agreement dated as of September 29, 2017 (as amended, modified, extended, renewed or replaced, the “Credit Agreement”), by and among Predators Holdings, LLC, a Delaware limited liability company (“Holdings”), Nashville Predators, LLC, a Delaware limited liability company (“Predators”), Nashville Hockey Club Limited Partnership, a Wisconsin limited partnership (“Club”), certain subsidiaries party thereto, the Collateral Agent and various lenders party thereto (collectively, the “Secured Parties”), Holdings, Predators, Club, each of the other subsidiaries party thereto and Collateral Agent previously entered into that certain Second Amended and Restated Security Agreement dated as of December 23, 2013 (as amended, restated, supplemented, modified, extended, renewed or replaced from time to time, the “Security Agreement”);

WHEREAS, on June 17, 2021 Grantor joined the Security Agreement as a Subsidiary Guarantor;

WHEREAS, pursuant to the Security Agreement, Grantor granted to the Collateral Agent, on behalf of the Secured Parties, a continuing security interest in, and a right to set off against, any and all right, title and interest of Grantor in and to (a) the Trademarks, and the goodwill of the business symbolized by the Trademarks and the applications, registrations and recordings in the United States Patent and Trademark Office (“USPTO”) or in any similar office or agency of the United States of America, any State thereof, all whether now or hereafter owned or licensable by Grantor; (b) all reissues, extensions or renewals thereof; (c) all of the Grantor’s rights, title and interest in and to any and all present and future license agreements with respect to the Trademarks; (d) all present and future accounts and other rights to payment arising from, in connection with or relating to the Trademarks; (e) all cash and non-cash proceeds of any and all of the foregoing; and (f) any claims by the Grantor against third parties and the right to recover for all past, present and future infringements or other violations of the foregoing (the “Trademark Collateral”), to secure the payment and performance of the Obligations; and

WHEREAS, pursuant to the Security Agreement, Grantor executed and delivered to Secured Party, the Grant of Security Interest in Trademarks recorded at the USPTO on June 17, 2021 recorded on Reel 7330, Frame 0076 (the “Notice”).

NOW THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Collateral Agent, on behalf of the Secured Parties, and Grantor agree as follows:

SECTION 1. Defined Terms. All capitalized terms used herein but not otherwise defined herein have the meanings given to them in the Security Agreement or the Notice, as applicable.

SECTION 2. Termination and Release. Collateral Agent, on behalf of the Secured Parties, without representation, warranty, or recourse, hereby:

(a) terminates, cancels, discharges, and releases the continuing security interest in, and the right to set off against, Grantor’s right, title, and interest in and to all the Trademark Collateral, including, but not limited to, the foregoing listed on Schedule 1 attached hereto, granted pursuant to the Security Agreement or the Notice; and


(b) authorizes the recordation of this Release with the USPTO at Grantor's expense.

SECTION 3. Further Assurances. The Collateral Agent, on behalf of the Secured Parties, hereby agrees to execute, acknowledge, procure and deliver any further documents and to do such other acts as may be reasonably necessary to effect the release of the security interests contemplated hereby.

SECTION 4. Choice of Law. This Release shall be governed by and construed in accordance with the laws of the State of Tennessee.

IN WITNESS WHEREOF, the Collateral Agent, on behalf of the Secured Parties, has caused this Termination and Release of Security Interest in Trademarks to be duly executed as of the date first set forth above.
