**TERMINATION AND RELEASE OF SECURITY INTEREST  
IN TRADEMARKS**

This **TERMINATION AND RELEASE OF SECURITY INTEREST IN TRADEMARKS** dated as of October 28, 2022 (“Release”), is made by Fifth Third Bank (the “Secured Party”), as successor in interest to Regions Bank (“Regions”), as Administrative Agent and Collateral Agent for the Lenders (as defined below) in favor of Nashville Hockey Club Limited Partnership, a Wisconsin limited partnership (“Grantor”).

**WHEREAS**, pursuant to that certain Second Amended and Restated Credit Agreement dated as of December 23, 2013 (as amended, modified, extended, renewed or replaced, the “Credit Agreement”), by and among Predators Holdings, LLC, a Delaware limited liability company (“Holdings”), Nashville Predators, LLC, a Delaware limited liability company (“Predators”), Grantor, Regions and various lenders party thereto (collectively, the “Lenders”), the Grantor and Regions entered into that certain Second Amended and Restated Security Agreement dated as of December 23, 2013 (as amended, restated, supplemented, modified, extended, renewed or replaced from time to time, the “Security Agreement”);

**WHEREAS**, pursuant to the Security Agreement, Grantor granted to Regions a continuing security interest in, and a right to set off against, any and all right, title and interest of Grantor in and to (a) the Trademarks, and the goodwill of the business symbolized by the Trademarks and the applications, registrations and recordings in the United States Patent and Trademark Office (“USPTO”) or in any similar office or agency of the United States of America, any State thereof, all whether now or hereafter owned or licensable by Grantor; (b) all reissues, extensions or renewals thereof; (c) all of the Grantor’s right, title and interest in and to any and all present and future license agreements with respect to the Trademarks; (d) all present and future accounts and other rights to payment arising from, in connection with or relating to the Trademarks; (e) all cash and non-cash proceeds of any and all of the foregoing; and (f) any claims by the Grantor against third parties and the right to recover for all past, present, and future infringements or violations of the foregoing (collectively, the “Trademark Collateral”) to secure the payment and performance of the Obligations;

**WHEREAS**, Regions, Secured Party, Holdings, Predators and Grantor entered into that certain Successor Agent Agreement, dated as of September 29, 2014 (“Successor Agreement”) wherein Secured Party replaced Regions as Administrative Agent and Collateral Agent under the Credit Agreement; and

**WHEREAS**, pursuant to the Successor Agreement, Regions filed that certain Notice of Assignment dated September 29, 2014 (the “Notice”), as recorded on October 3, 2014 at the USPTO in Reel 005374, Frame 0754, assigning all of its rights, title and interest in the Trademark Collateral to Secured Party.

**NOW THEREFORE**, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Secured Party and Grantor agree as follows:

**SECTION 1. Defined Terms.** All capitalized terms used herein but not otherwise defined herein have the meanings given to them in the Security Agreement or the Notice, as applicable.

**SECTION 2. Termination and Release.** Secured Party without representation, warranty, or recourse, hereby:

(a) terminates, cancels, discharges, and releases the continuing security interest in, and the right to set off against, Grantor’s right, title, and interest in and to all the Trademark Collateral, including, but not limited to, the foregoing listed on Schedule 1 attached hereto, granted pursuant to the Security Agreement or the Notice; and

(b) authorizes the recordation of this Release with the USPTO at Grantor's expense.


**SECTION 3. Further Assurances.** The Secured Party hereby agrees to execute, acknowledge, procure and deliver any further documents and to do such other acts as may be reasonably necessary to effect the release of the security interests contemplated hereby.

**SECTION 4. Choice of Law.** This Release shall be governed by and construed in accordance with the laws of the State of Tennessee.






