TRADEMARK ASSIGNMENT AGREEMENT

THIS ASSIGNMENT of trademark rights (this “**Assignment**”) is made effective as of the 7th day of October, 2022 by and between Genuine Autoglass, Inc., a Washington Corporation (“**Assignor**”), and Safelite Fulfillment, Inc., a Delaware corporation (“**Assignee**”).

WHEREAS, consistent with the provisions of that Asset Purchase Agreement, Assignor wishes to assign to Assignee and Assignee wishes to acquire all right, title, and interest in the Marks, including the goodwill of the business associated therewith.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which is hereby expressly acknowledged, Assignor does hereby assign, transfer and convey unto Assignee, all of its right, title, and interest in and to the Marks together with the goodwill of the business connected with the use of and symbolized by the Marks, as well as all rights of action against third parties for past infringement thereof.

Assignor further covenants and agrees that it has the right and authority to make this assignment and has not assigned the Marks to any third party.
