**ASSIGNMENT OF INTELLECTUAL PROPERTY**

This ASSIGNMENT OF INTELLECTUAL PROPERTY (this “**Assignment**”) is made and executed effective as of October 17, 2022 by Holding Company I, Inc., a Delaware corporation (“**Assignor**”), in favor of L’Oréal USA Creative, Inc., a Delaware corporation (“**Assignee**”). Capitalized terms not otherwise defined in this Assignment will have the meanings ascribed to such terms in the Contribution Agreement (as defined below).

WHEREAS, Assignor, Assignee, L’Oréal USA, Products and S/D have entered into that certain Contribution Agreement, dated as of October 17, 2022 (the “**Contribution Agreement**”);

WHEREAS, pursuant to the Contribution Agreement, Assignor agreed to contribute, assign and transfer to Assignee, and Assignee agreed to accept the Remaining Purchased Assets and Transferred Assets, including the Transferred Marks, Transferred Domain Names and Transferred Copyrights.

NOW, THEREFORE, in consideration of the above promises, and other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the parties hereby agree as follows:

1. **Transfer of Transferred Marks, Transferred Domain Names and Transferred Copyrights.** Assignor hereby assigns to Assignee and its successors all of Assignor’s right, title and interest in and to the Transferred Marks, Transferred Domain Names and Transferred Copyrights (including without limitation, those set forth on **Exhibit A**) and including without limitation, all common law rights relating thereto and all registrations thereof and applications therefor, together with all goodwill associated with, corresponding to, symbolized by and embodied in such trademarks and domain names, and including without limitation the right to commence an action and recover for past, present and future infringement of such trademarks, domain names and copyrights.

2. **Exclusions.** For the avoidance of doubt, the intellectual property assigned pursuant to this Assignment does not include certain intellectual property and related assets which have been sold to L’Oréal Parent pursuant to that certain Purchase Agreement, dated as of October 17, 2022, by and between L’Oréal USA and L’Oréal Parent.

3. **Recordation of Assignment.** Assignor will cooperate with Assignee to record this Assignment with the appropriate governmental entities in all jurisdictions designated by Assignee, including without limitation, the United States Patent and Trademark Office and United States Copyright Office.

4. **Binding Effect; Successors and Assigns.** This Assignment shall be binding upon and inure to the benefit of the parties hereto and their respective heirs, legal representatives, successors and permitted assigns. Nothing herein expressed or implied shall give, or be construed to give, to any Person, other than the parties hereto and their permitted assigns, any right, remedies or claims under or with respect to this Assignment or any provisions hereof.

5. Counterparts. This Assignment may be executed in any number of counterparts, each of which when so executed shall be deemed to be an original but all of which together shall constitute one and the same instrument. Delivery of an executed counterpart of a signature page of this Assignment by facsimile transmission or by electronic transmission of a .pdf or other electronic file shall be as effective as delivery of a manually executed counterpart of this Assignment.

6. Governing Law. This Assignment shall be governed by, and construed in accordance with, the laws of the State of New York applicable to contracts made and performed in such State, without reference to conflict of law principles, including all matters of construction, validity and performance.
