**ASSIGNMENT OF LIENS  
AND SECURITY INTERESTS**

This Assignment of Liens and Security Interests (this “Assignment”), dated effective as of November 14, 2018, is from **WILMINGTON TRUST, NATIONAL ASSOCIATION**, as Collateral Agent (in such capacity, the “Assignor”), with an address at 166 Mercer Street, Suite 2R, New York, NY 10012, to **CANTOR FITZGERALD SECURITIES**, as Collateral Agent (in such capacity, “Assignee”), with an address at 110 East 59th Street, New York, New York 10022, and acknowledged by the Issuers (as defined below). Capitalized terms used herein and not otherwise defined shall have the meanings assigned to them in the Indenture (as defined below).

**RECITALS**

WHEREAS, IronGate Energy Services, LLC (“IES”), IES Finance Corporation (“IES Finance”, and together with IES, the “Issuers”), IronGate Rental Services, LLC (“IronGate Rental”), IronGate Tubular Services, LLC (“IronGate Tubular”), Green Light Energy Services, Inc. (“Green Light”), Sun Tubular Services, LLC (“Sun Tubular”) and IronGate Energy Holdings, LLC (“IronGate Holdings”, and collectively with IronGate Rental, IronGate Tubular, Green Light, and Sun Tubular, the “Guarantors”), and the Assignor are parties to that certain Indenture dated as of June 27, 2013 (as modified from time to time, the “Indenture”);

WHEREAS, concurrently herewith, the Issuers and the Guarantors have entered into that certain Master Secured Promissory Note in an aggregate principal amount of \$27,073,900.70; and

WHEREAS, Assignor and Assignee desire to enter into this Assignment in order to transfer of record to Assignee all liens and security interests presently held by Assignor under the instruments described on **Schedule I**.

NOW THEREFORE, for good and valuable consideration, the receipt, adequacy and sufficiency of which are hereby acknowledged, the parties hereby agree to the following:

**WITNESSETH:**

1. Assignment. Assignor has granted, bargained, sold, assigned, transferred, set over, delivered and conveyed, and does by these presents grant, bargain, sell, assign, transfer, set over, deliver and convey to Assignee, all of Assignor’s right, title and interest as Collateral Agent in and to all liens and security interests created under the Indenture

Documents, and Collateral held by, the Assignor, in each case securing the Issuers' and the Guarantors' indebtedness, obligations, and liabilities arising under the Indenture and the other Indenture Documents, including but not limited to those certain security agreements, mortgages, deeds of trust and other collateral documents executed in favor of Assignor as described in **Schedule I** attached hereto and incorporated herein for all purposes by this reference against the property described therein. The assignment pursuant to this Section 1 is made on an "as is" basis, without representation or warranty, express or implied, and neither Assignor nor Assignee has any responsibility for the validity, enforceability or perfection of the liens and security interests assigned hereby. Cantor Fitzgerald Securities is entering into this letter solely in its capacity as "Collateral Agent" under the Master Secured Promissory Note and is entitled to all benefits and indemnities contained therein.

2. Further Assurances. Assignor hereby covenants and agrees with Assignee to execute such other and further instruments of assignment and/or transfer as may be reasonably necessary to effectuate the purposes of this Assignment. Assignee and its designees are hereby authorized to file of record or cause to be filed any Uniform Commercial Code financing statement assignments and record copies of this Assignment. Without limiting the foregoing, Assignor and Assignee agree to take such actions and make such modifications to **Schedule I** as reasonably deemed necessary by the Issuers to effectuate the recordation of this Assignment.
3. Counterparts. For the convenience of the parties, this Assignment may be executed in multiple counterparts. Each of the counterparts hereof so executed shall for all purposes be deemed to be an original, and all such counterparts shall together constitute one and the same instrument. For recording purposes, various counterparts have been executed, and there may be attached to each such counterpart a schedule containing the filing or recording data for certain mortgages and/or deeds of trust in favor of the Assignor recorded in the parish or county in which the particular counterpart hereof is to be recorded, and certain counterparts hereof may include (as an attachment to **Schedule I**) exhibits to such mortgages and/or deeds of trust which contain descriptions of properties located in (or otherwise subject to the requirements and/or protections of the recording or filing acts or regulations of) the recording jurisdiction in which the particular counterpart is to be recorded.
4. Governing Law. THIS AGREEMENT AND THE RIGHTS AND OBLIGATIONS OF THE PARTIES UNDER THIS AGREEMENT SHALL BE GOVERNED BY, AND CONSTRUED AND INTERPRETED IN ACCORDANCE WITH, THE LAW OF THE STATE OF NEW YORK, WITHOUT REFERENCE TO THE CONFLICTS OF LAWS PROVISIONS THEREOF, except to the extent necessarily governed by the laws of the other states in which any property subject to the liens and security interests assigned hereunder is located.

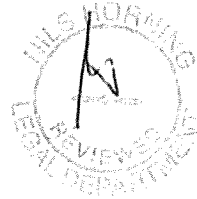

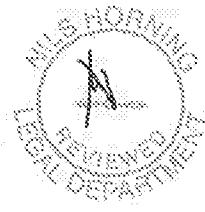

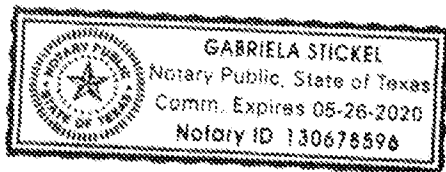
