# INTELLECTUAL PROPERTY ASSIGNMENT AGREEMENT

This Intellectual Property Assignment Agreement (this "IP Assignment"), dated as of November 2, 2022 (the "Effective Date"), is being executed and delivered by Woods Equipment Company (f/k/a WEC Company and as successor to Woods Construction Equipment), a Delaware corporation ("Seller"), and Oregon Tool, Inc. (f/k/a Blount, Inc.), a Delaware corporation ("Parent;" together with Seller, the "Assignors" and individually, an "Assignor"), to Epiroc Drilling Tools LLC, a Delaware limited liability company ("Purchaser" and, together with Assignors, the "Parties" and each are individually referred to as a "Party"), pursuant to the terms of that certain Asset Purchase Agreement, dated as of the October 19, 2022, by and between Purchaser and Seller (the "APA"). To the extent that any provision of this Assignment is inconsistent with the APA, the APA shall control. Capitalized terms used and not otherwise defined herein have the meanings ascribed to them in the APA.

WHEREAS, each Assignor desires to convey, transfer, and assign to Purchaser all intellectual property of such Assignor related to the Business in connection with the transactions contemplated by the APA;

NOW THEREFORE, the Parties agree as follows:

- 1. <u>Assignment</u>. For good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, each Assignor hereby irrevocably conveys, transfers, and assigns to Purchaser, and Purchaser hereby accepts, all of such Assignor's right, title, and interest in and to the following Intellectual Property Rights used or held for use in the Business (the "<u>Assigned IP</u>"):
- (a) all patents, patent applications, and inventions and discoveries that may be patentable (including all related provisionals, continuations, continuations-in-part, divisionals, reissues, renewals, and extensions, and all priority rights and rights under any international patent conventions, agreements or treaties, the United States or any other jurisdiction;
- (b) all fictional business names, trading names, registered and unregistered trademarks/service marks, registered designs, and applications therefor, including, without limitation, those set forth on <u>Schedule 1</u> hereto (and all issuances, extensions, and renewals thereof) (the "<u>Trademarks</u>"), together with the goodwill of the business connected with the use of, and symbolized by, the Trademarks; provided that, with respect to the United States intent-to-use trademark applications set forth on <u>Schedule 1</u> hereto, the transfer of such applications accompanies, that portion of the business to which the trademark pertains, and that business is ongoing and existing;
  - (c) all copyrights in both published works and unpublished works;
- (d) manufacturing methods, supplier lists, software, trade secrets, confidential information, know-how, technology, technical information, data, process, schematics, plans, drawings, blueprints and customer lists, supplier lists and all documentation relating to any of the foregoing regardless of the stage of development, including, without limitation, those set forth on **Schedule 2** (collectively, the "Trade Secrets");
- (e) the internet domain name registrations and social media sites owned or used by the Business or that use any derivative of the Trademarks, including, without limitation, those set forth on **Schedule 3** hereto (collectively, the "Domain Names");

- (f) all computer software (including source code, executable code, data, databases and related documentation), regardless of the stage of development;
  - (g) all licenses, sublicenses, and other agreements;
  - (h) all advertising and promotional materials;
- (i) all other proprietary rights; and all copies and tangible embodiments thereof (in whatever form or medium) owned, used, or licensed by each Assignor as licensee or licensor and related to the Business;
  - (i) all moral and economic rights of authors and inventors, in the foregoing;
- (k) all rights of any kind whatsoever of each Assignor accruing under any of the foregoing provided by applicable law of any jurisdiction, by international treaties and conventions, and otherwise throughout the world;
- (l) any and all royalties, fees, income, payments, and other proceeds now or hereafter due or payable with respect to any and all of the foregoing; and
- (m) any and all claims and causes of action with respect to any of the foregoing, whether accruing before, on, or after the date hereof, including all rights to and claims for damages, restitution, and injunctive and other legal and equitable relief for past, present, and future infringement, dilution, misappropriation, violation, misuse, breach, or default, with the right but no obligation to sue for such legal and equitable relief and to collect, or otherwise recover, any such damages.
- **2.** Recordation and Further Actions. Each Assignor hereby authorizes the Commissioner for Patents and the Commissioner for Trademarks in the United States Patent and Trademark Office, the Register of Copyrights in the United States Copyright Office, and the officials of corresponding entities or agencies in any applicable jurisdictions to record and register this IP Assignment upon request by Purchaser. Following the date hereof, upon Purchaser's reasonable request, and at Purchaser's sole cost and expense, each Assignor shall take such steps and actions, and provide such cooperation and assistance to Purchaser and its successors, assigns, and legal representatives, including the execution and delivery of any affidavits, declarations, oaths, exhibits, assignments, powers of attorney, or other documents, as may be reasonably necessary to effect, evidence, or perfect the assignment of the Assigned IP to Purchaser, or any assignee or successor thereto.
- **3.** Governing Law. This IP Assignment and any claim, controversy, dispute, or cause of action (whether in contract, tort, or otherwise) based upon, arising out of, or relating to this IP Assignment shall be governed by, and construed in accordance with, the laws of the United States and the State of Delaware, without giving effect to any choice or conflict of law provision or rule (whether of the State of Delaware or any other jurisdiction).
- **4.** <u>Miscellaneous</u>. To the extent that any provision of this Assignment is inconsistent with the APA, the APA shall control. This IP Assignment may be executed in counterparts, each of which shall be deemed an original, but all of which together shall be deemed one and the same agreement.


