**TERMINATION AND RELEASE OF SECURITY INTEREST
IN TRADEMARKS**

This **TERMINATION AND RELEASE OF SECURITY INTEREST IN TRADEMARKS**, dated as of October 19, 2022 (“Release”), is made by BNP Paribas, as Collateral Agent (“Collateral Agent”) in favor of Nasco Healthcare Inc. (f/k/a The Aristotle Corporation), a Delaware corporation (the “Grantor”).

WHEREAS, pursuant to that certain Pledge and Security Agreement, dated as of June 30, 2015 (as amended, restated, supplemented or otherwise modified from time to time, the “Security Agreement”), by and among the Grantor, Collateral Agent, and others party thereto, and the Intellectual Property Security Agreement, dated as of March 2, 2016 (as amended, restated, supplemented or otherwise modified from time to time, the “Trademark Security Agreement”), by and among the Grantor and Collateral Agent, the Grantor granted to the Collateral Agent a security interest in and continuing lien on all of the Grantor’s right, title and interest in, to and under the Trademarks; and

WHEREAS, the Trademark Security Agreement was recorded at the United States Patent and Trademark Office (“USPTO”) on March 2, 2016 at Reel 005743 Frame 0945.

NOW THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Collateral Agent, on behalf of the Secured Parties, and the Grantor agree as follows:

SECTION 1. Defined Terms. All capitalized terms used herein but not otherwise defined herein have the meanings given to them in the Security Agreement or Trademark Security Agreement.

SECTION 2. Termination and Release. Collateral Agent, on behalf of the Secured Parties, without any representation, warranty, recourse, or undertaking of any kind (whether express or implied), hereby:

(a) terminates, cancels, discharges, and releases the security interest in and continuing lien on all of the Grantor’s right, title and interest in, to and under the Trademarks, including, but not limited to, the foregoing listed on Schedule A attached hereto, granted pursuant to the Security Agreement or the Trademark Security Agreement; and

(b) authorizes the recordation of this Release with the USPTO at the Grantor’s expense.

SECTION 3. Choice of Law. This Release shall be governed by and construed in accordance with the laws of the State of New York.

IN WITNESS WHEREOF, the Collateral Agent, on behalf of the Secured Parties, has caused this Termination and Release of Security Interest in Trademarks to be duly executed as of the date first set forth above.
