Pursuant to Section 264(c) of the Delaware General Corporation Law (the “**DGCL**”) and Section 18-209 of the Delaware Limited Liability Company Act (the “**LLC Act**”), L’Oréal USA, Inc., a Delaware corporation (the “**Surviving Corporation**”), in connection with the merger of DermaForce Holdings LLC, a Delaware limited liability company, with and into the Surviving Corporation (the “**Merger**”), submits this Certificate of Merger for filing:
