INTELLECTUAL PROPERTY ASSIGNMENT AGREEMENT

This INTELLECTUAL PROPERTY ASSIGNMENT AGREEMENT (“Assignment”) is made effective as of August 9, 2022, by and between KORE OUTDOOR ULC, a company previously existing under the laws of British Columbia (the “Assignor”), and KORE OUTDOOR LTD., a corporation incorporated under the laws of Ontario (the “Assignee”).

WHEREAS, as of August 9, 2022, Assignor owned the entire right, title and interest in the patents and patent applications listed in Schedule A attached hereto (referred to collectively as the “Patents”);

WHEREAS, as of August 9, 2022, Assignor owned the entire right, title and interest in and to the trademarks, trademark registrations, and trademark applications identified on Schedule B attached hereto together with the goodwill of the business symbolized thereby and related thereto (collectively, the “Marks”);

WHEREAS, the Patents and Marks are collectively referred to as the “Intellectual Property”;

WHEREAS, Assignor and Assignee have entered into, *inter alia*, that certain “Distribution and Assumption Agreement” dated August 9, 2022, pursuant to the terms of which Assignor agreed to and did assign all right, title and interest of Assignor in and to the Intellectual Property to Assignee together with the goodwill of the business symbolized thereby and associated therewith, and pursuant to which Assignor assigned the entire business associated with the Intellectual Property to Assignee, and whereby Assignee is a successor to the business of the Assignor to which the Marks pertain;

WHEREAS, accordingly, Assignee did acquire, as of August 9, 2022, the entire right, title and interest in and to the Intellectual Property and the business and goodwill of the business in connection with which the aforesaid Intellectual Property had been used;

WHEREAS, Assignor agreed to execute such additional instruments as may be necessary or desirable to confirm such assignment to Assignee; and

WHEREAS, Assignor and Assignee are desirous of making this Assignment a matter of record in the U.S. Patent and Trademark Office, and other patent and trademark offices around the world in the relevant jurisdictions.

NOW, THEREFORE, in consideration of the foregoing, and other good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, Assignor hereby confirms that effective as of August 9, 2022, Assignor did convey, transfer and assign to Assignee, and hereby does convey, transfer and assign to Assignee, its successors and assigns, the entire right, title, and interest of Assignor in

and to said Intellectual Property, together with the goodwill of the business symbolized by and associated with the aforesaid Intellectual Property, and all claims, if any, which may have accrued or arisen thereunder prior to the effective date of this Assignment, including, but not limited to, the right to bring any causes of action, both in equity and law, for any past, present and future infringement or infringements of the Intellectual Property including any accruing on or before August 9, 2022, and to collect and recover any and all claims for past, present and future damages, profits and costs for any past, present and future infringement or infringements of the Intellectual Property including any accruing on or before August 9, 2022.


This Assignment may be executed in counterparts, each of which will be deemed to be an original and both of which taken together will be deemed to constitute one and the same instrument. Delivery of an executed signature page to this Assignment by any party by electronic transmission will be as effective as delivery of a manually executed copy of the Assignment by such party.
