## RELEASE OF SECURITY INTEREST IN INTELLECTUAL PROPERTY

The Secured Party hereby authorizes Grantor or Grantor’s authorized representative to record or file this Release of Security Interest in Intellectual with the USPTO or any other applicable governmental office or agency. The Secured Party further agrees to execute and deliver to Grantor any and all further documents and instruments, and to do all further acts which Grantor (or its agents or designees) reasonably request (at Grantor’s sole cost and expense) to confirm this Release of Security Interest in Intellectual Property and Grantor’s right, title, and interest in and to the Released Intellectual Property.

This Release of Security Interest in Intellectual Property shall be governed by and construed in accordance with the laws of the State of New York as applied to agreements among parties resident therein.
