TERMINATION AND RELEASE OF
SECURITY INTEREST IN U.S. TRADEMARKS AND COPYRIGHTS

This **TERMINATION AND RELEASE OF SECURITY INTEREST IN U.S. TRADEMARKS AND COPYRIGHTS** (this “Release Agreement”), dated as of October 18, 2022 is made by **BANK OF AMERICA, N.A.**, a national banking association, as Agent (the “Grantee”) in favor of **HYPER PRODUCTS, INC.** (formerly *Sanho Corporation*), a Delaware corporation (the “Grantor”).

WHEREAS, the Grantor and the Grantee are parties to that certain Memorandum and Notice of Security Interest in Intellectual Property dated as of September 2, 2021 (the “Security Agreement”), whereby the Grantor granted to the Grantee a security interest in the trademarks, trademark applications and registered copyrights listed on Schedule A attached hereto (collectively, the “IP Collateral”) for recordation with the United States Patent and Trademark Office and the United States Copyright Office; and

WHEREAS, the Security Agreement was recorded with the Trademark Division of the United States Patent and Trademark Office on September 3, 2021 at Reel 007413, Frame 0374; and

WHEREAS, the obligations secured by said security interest have been paid in full or otherwise satisfied; and

WHEREAS, the Grantee has agreed to terminate and release its security interest and all of its right, title and interest in each of the IP Collateral, as herein provided.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Grantee hereby agrees as follows:

1. **Definitions.** All capitalized terms used but otherwise not defined herein shall have the meaning ascribed to them in the Security Agreement.

2. **Release and Assignment.** The Grantee hereby irrevocably discharges, terminates and releases the entirety of its security interest in, and hereby irrevocably assigns to the Grantor any other right, title or interest that the Grantee may have in or to, the IP Collateral.

3. **Recordation.** The Grantee hereby authorizes and requests that the United States Patent and Trademark Office and the United States Copyright Office note and record the releases and terminations granted under this Release Agreement, and authorizes any other filings necessary to evidence the termination, release and discharge of the Grantee’s security interests, liens and other rights granted under the Security Agreement with respect to the IP Collateral.

4. **Further Assurances.** The Grantee hereby agrees to execute, acknowledge and deliver all such further instruments and to take all such further actions as may be reasonably requested or are required in order to more fully and effectively carry out the purposes of this Release Agreement at the Grantor’s sole cost and expense.

5. **Governing Law.** This Release Agreement and the rights and obligations of the parties hereunder shall be governed by, and shall be construed and enforced in accordance with, the laws of the State of California.
