Pursuant to the provisions of Act 284, Public Acts of 1972 (the "Business Corporation Act") and Act 213, Public Acts of 1982 (the "Revised Uniform Limited Partnership Act"), the undersigned entities execute the following Certificate of Merger:

1. The Plan of Merger is as follows:
 - (a) The name of each constituent entity and its identification number is:

Performance Fabrics, Inc., a Michigan corporation, identification number 800596461


New PFI, Limited Partnership, a Michigan limited partnership, identification number 802887553
 - (b) New PFI, Limited Partnership is the constituent entity that will be the surviving entity and its identification number is 802887553 (the "Surviving Partnership").
2. The merger shall be effective on July 30, 2022 ("Effective Time").
3.
 - (a) Performance Fabrics, Inc. has 336,640 shares of Class A Common Stock and 2,391,237 shares of Class B Common Stock issued and outstanding. All of these shares are entitled to vote as one single class of common stock.
 - (b) By virtue of the merger, all shares of Class A Common Stock and of Class B Common Stock of Performance Fabrics, Inc. that were issued and outstanding immediately prior to the Effective Time shall be cancelled.
 - (c) The Board of Directors and the shareholders of Performance Fabrics, Inc. approved the Plan of Merger in accordance with Section 450.1703a of the Business Corporation Act.
4.
 - (a) The partners of New PFI, Limited Partnership approved the Plan of Merger in accordance with Section 449.1210(3) of the Revised Uniform Limited Partnership Act.
 - (b) Immediately prior to the Effective Time, 336,640 Class A limited partnership interests, 2,391,237 Class B limited partnership interests and 2,728 general partnership interests of the Surviving Partnership were issued and outstanding. All of these partnership interests shall remain issued and outstanding and shall not be affected by the merger.

- (c) The survivor is a limited partnership. Its Certificate of Limited Partnership, as amended, shall be further amended to change the name of the survivor to "HexArmor, Limited Partnership" as of the Effective Time.


