**TERMINATION AND RELEASE OF
INTELLECTUAL PROPERTY SECURITY AGREEMENT**

THIS TERMINATION AND RELEASE OF INTELLECTUAL PROPERTY SECURITY AGREEMENT (this "Release") is made as of this 31st day of October 2022, by PNC BANK, NATIONAL ASSOCIATION, in its capacity as agent ("Agent"), in favor of UNISOFT INTERNATIONAL, INC. a Texas corporation (the "Grantor").

WHEREAS, Grantor entered into a certain Intellectual Property Security Agreement, dated September 4, 2020, with Agent, notice of which was recorded with the United States Patent and Trademark Office ("USPTO") on September 10, 2020, at reel/frame 7048/0462 (the "IP Security Agreement"). Capitalized terms used but not otherwise defined herein have the meanings given to them in the IP Security Agreement.

WHEREAS, Grantor granted to Agent, under the terms of the IP Security Agreement, a continuing security interest in favor of Agent, in and to all its right, title and interest in and to the IP Collateral, including without limitation the intellectual property listed in Schedule I attached hereto.

WHEREAS, Agent has agreed to terminate and release its security interest in all such IP Collateral as herein provided.

FOR GOOD AND VALUABLE CONSIDERATION, the receipt and adequacy of which are hereby acknowledged, Agent hereby (a) releases, terminates and discharges its security interest in, and Lien on, the IP Collateral, including the intellectual property listed on Schedule I attached hereto and made a part hereof, (b) terminates the IP Security Agreement and (c) assigns, transfers and conveys to Grantor any right, title or interest, including the security interest, it may have in the IP Collateral, including the intellectual property listed on Schedule I attached hereto and made a part hereof. Grantor, or any successor to Grantor (including any person or entity

hereafter having any right, title or interest in or to the IP Collateral), is hereby authorized to record this Release with the USPTO.
