RELEASE OF SECURITY INTEREST IN TRADEMARKS

WHEREAS, pursuant to that certain Trademark Security Agreement dated as of August 23, 2017 by and among PRIMEX, INC., a Wisconsin corporation (“Primex”), COMBEX, INC., a Wisconsin corporation (“Combex”), PRIMEX WIRELESS, INC., a Wisconsin corporation (“Wireless”), and together with Primex and Combex, collectively, “Obligors” and each an “Obligor”), and CIBC BANK USA, formerly known as The PrivateBank and Trust Company (“Lender”) (as amended, restated, modified or supplemented, the “Trademark Security Agreement”; capitalized terms used herein and not defined herein shall have the ascribed to them in the Trademark Security Agreement), recorded with the United States Patent and Trademark Office – Trademark Division on September 11, 2017 at Reel 006151, Frame 0340, Combex granted to Lender a security interest in all right, title and interest of Combex in and to all trademarks, including those referred to on Schedule 1 attached hereto, all goodwill of the business connected with the use of, and symbolized by, each trademark, and all rights to sue at law or in equity for any infringement or other impairment of the foregoing, including the right to receive all proceeds and damages thereof (collectively, the “Trademark Collateral”); and

WHEREAS, Lender wishes to provide a document suitable for recording in the United States Patent and Trademark Office for purposes of recording the release, relinquishment and discharge of its security interest in and to the Trademark Collateral.

NOW, THEREFORE, in consideration of and in exchange for good and valuable consideration, Lender, on behalf of itself, its successors, legal representatives and assigns, hereby (a) relinquishes, releases and discharges its security interest in and to the Trademark Collateral and (b) assigns to Combex any right, title and interest in and to the Trademark Collateral that Lender may have.
