## REASSIGNMENT AND RELEASE OF SECURITY INTEREST

This Reassignment and Release of Security Interest (this “**Reassignment and Release**”) is made as of November 3, 2022 and deemed to be effective as of October 12, 2022 (the “**Release Date**”), by WESTERN ALLIANCE BANK, an Arizona corporation (“**Bank**”) in favor of BARIUM AB, a limited liability company incorporated under the laws of Sweden (“**Grantor**”).

### RECITALS

WHEREAS, Grantor granted to InRule Technology, Inc., a Delaware corporation (“**Inrule**”) a security interest in its trademarks described on Exhibit B (collectively, the “**Trademarks**”), under an Intellectual Property Rights Pledge Agreement among Grantor, Inrule and Bank (as security agent) dated as of December 6, 2021 (as may be amended, restated, supplemented or otherwise modified, the “**Pledge Agreement**”), and recorded with the respective Intellectual Property Offices in the jurisdictions set forth on Exhibit B. All capitalized terms used in this Reassignment and Release and not otherwise defined herein have the meaning given in the Pledge Agreement.

WHEREAS, Grantor, Inrule, IR BAR Acquisition AB (collectively, the “**Obligors**”) and Bank entered into a release letter dated October 12, 2022, pursuant to which the Bank released each of the Obligors from any security interest the Bank held in the assets exhibited thereto, including the Trademarks (the “**Release Letter**”).

WHEREAS, with effect from the Release Date Grantor has no outstanding obligations to Inrule or the Bank under the terms of the Pledge Agreement, and Bank has released its security interest in the Trademarks pursuant to the Release Letter. This Reassignment and Release has been entered into for the sole purpose of notifying the Intellectual Property Offices in the jurisdictions set forth on Exhibit B of Bank’s release of the security interest in the Trademarks.

### AGREEMENT

Now therefore, with effect from the Release Date, Bank has terminated, discharged, cancelled, and released its security interest in the Trademarks pursuant to the Pledge Agreement and reassigned to Grantor, without warranty or recourse, all interest of Bank in the Trademarks. With effect from the Release Date, Bank has terminated, without representation or warranty of any kind, the Pledge Agreement. Bank will take all further actions, and provide Grantor and its successors, assigns, or other legal representatives, all such cooperation and assistance reasonably requested by such Grantor, at such Grantor’s sole cost and expense, to more fully and effectively effectuate the purposes of this Reassignment and Release.
