RELEASE OF SECURITY INTEREST IN INTELLECTUAL PROPERTY

This **RELEASE OF SECURITY INTEREST IN INTELLECTUAL PROPERTY** (the “Release”) by Touch of Modern LLC, (“Lienholder”) is effective *nunc pro tunc* as of May 27, 2022.

W I T N E S S E T H

WHEREAS, as of August 30, 2018, TouchofModern, Inc. (“TOMI”) was the owner of the patents, patent applications, trademarks, trademark applications, and copyrights identified in Schedule A attached hereto (collectively, the “Intellectual Property”);

WHEREAS, effective as of August 30, 2018, TOMI granted to Multiplier Capital II, LP (“Multiplier”) a security interest in the Intellectual Property (the “Security Interest”), which Security Interest was evidenced by certain filings with the United States Patent and Trademark Office (“USPTO”), including without limitation (i) that certain Intellectual Property Security Agreement dated August 30, 2018 and recorded with the USPTO on May 16, 2022 for United States Pat. No. 9,742,760 and United States Patent Application No. 14744718 at Reel 059921 Frame 0289, and (ii) that certain Intellectual Property Security Agreement dated August 30, 2018 and recorded with the USPTO on May 16, 2022 for United States federal trademarks with serial numbers 86/152,836, 86/152,840, 86/711,549, 86/711,566, 86/714,742, 87/295,237, and 87/336,989 at Reel 7722 Frame 0283;

WHEREAS, pursuant to that certain Assignment of Loan between Multiplier and Lienholder, dated as of May 26, 2022, Multiplier sold, conveyed, assigned, transferred and set over to Lienholder, and Lienholder acquired from Multiplier, the Security Interest; and

WHEREAS, pursuant to that certain Asset Purchase Agreement dated as of May 27, 2022, by and between TOMI and Lienholder, TOMI sold, conveyed, assigned, transferred and set over to Lienholder all of its right, title and interest in and to the Intellectual Property;


WHEREAS, Lienholder, as the exclusive owner of all right, title and interest in and to the Intellectual Property, wishes to discharge, terminate and release the Security Interest it holds by virtue of the May 27, 2022 assignment from TOMI in and to the Intellectual Property.

NOW, THEREFORE, in consideration of the foregoing, Lienholder hereby DISCHARGES, TERMINATES and RELEASES, without recourse, representation or warranty, the Security Interest in the Intellectual Property, including the patents, patent applications, trademark registrations, trademark applications, and copyright registrations set forth in Schedule A attached hereto and incorporated herein by reference.


