**TRADEMARK ASSIGNMENT AGREEMENT**

This Trademark Assignment Agreement (this “Assignment”) is made and entered into as of October 4, 2022 (“Effective Date”), by and between Change Healthcare Operations, LLC, a Delaware limited liability company (“Assignor”), and Magnum Transaction Sub, LLC, a Delaware limited liability company (“Assignee”). Capitalized terms used but not defined herein shall have the meanings set forth in the Purchase Agreement (defined below) or the Contribution Agreement (defined below), as applicable.

**WHEREAS**, pursuant to that certain Equity Purchase Agreement by and between UnitedHealth Group Incorporated and Color Intermediate, LLC, dated as of April 22, 2022 (the “Purchase Agreement”), Assignor and Assignee have entered into that certain Contribution Agreement by and among Change Healthcare Holdings, LLC, Change Healthcare Technologies, LLC, Assignor, UnitedHealth Group Incorporated and Assignee, dated as of October 3, 2022 (the “Contribution Agreement”);

**WHEREAS**, pursuant to the Contribution Agreement, Assignor conveyed, transferred, assigned and delivered to Assignee, and Assignee accepted, all of Assignor’s right, title and interest in, to and under the trademark set forth on Schedule A, together with all goodwill associated therewith (the “Assigned Trademark”) and the domain name set forth on Schedule B (the “Assigned Domain Name”); and

**WHEREAS**, in accordance with and subject to the terms of the Contribution Agreement, Assignor has agreed to execute this Assignment.

**NOW, THEREFORE**, for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, the parties, intending to be legally bound, hereby agree as follows:

1. **Assignment**. Assignor hereby irrevocably conveys, transfers, assigns and delivers to Assignee, and Assignee hereby accepts, all of Assignor’s right, title and interest in, to and under the Assigned Trademark and the Assigned Domain Name. The parties acknowledge and agree that Assignee shall hold all right, title and interest in and to the Assigned Trademark and Assigned Domain Name as fully and exclusively as the same would have been held and enjoyed by Assignor on the Effective Date had the above assignment not been made.
2. **Recordation**. Assignor hereby authorizes and requests the Commissioner of Trademarks of the United States Patent and Trademark Office to record and register Assignee as the assignee and owner of the Assigned Trademark.
3. **Federal Income Tax Treatment**. If this Assignment is regarded as a transfer of the Assigned Trademark and the Assigned Domain Name from Assignor to Assignee for U.S. federal income tax purposes, the parties hereto agree that such transfer will be treated as transfers of the Assigned Trademark from Assignor to Assignee through the ownership chain.
4. **Miscellaneous**. This Assignment, together with the Contribution Agreement, constitutes the entire agreement between the parties with respect to the subject matter hereof. This

Assignment is entered into pursuant to the terms of the Contribution Agreement. In the event of any conflict between this Assignment and the Contribution Agreement, the Contribution Agreement shall control. Assignor and Assignee agree that any and all representations and warranties relating to the Assigned Trademark are set forth in the Purchase Agreement, and no additional representations or warranties, express or implied, are given in this Assignment. This Assignment may be executed in one or more counterparts, each of which shall be deemed an original, and all of which shall constitute one and the same agreement.
